Subject: Written Complaint regarding fraudulent flight ticket bookings

Respected Sir,

I, Mr. Atul Tuli, son of Mr. Vinod Kumar Tuli authorised Signatory of Air IQ Online Pvt. Ltd., a private limited company, incorporated under the provisions of The Companies Act 2013, having its registered office at Asmi Square, 2nd Floor, 2nd Mile, Post Office - Sevoke Road, Police Station - Bhaktinagar, District - Jalpaiguri, Pin - 734001, West Bengal am writing to lodge a formal complaint regarding a cyber-fraud involving airline ticket bookings through our system/platform.

Our company operates a business-to-business (B2B) airline ticketing platform where we provide airline tickets from various airlines and make them available to our registered agents. These agents then book and sell the tickets to end/retail customers or travellers. We do not sell directly to individual passengers. Our platform operates via an online application programming interface (API) which connects to various airline companies and authorised third-party agents. Each agent has their own login ID to access the platform to search and book air tickets. In addition, our company has an admin portal with separate logins for various airlines to facilitate bookings when needed.

It is pertinent to mention here that our company checks and tallies all the records of tickets purchased and sold every week by agents for the end customers to make sure all accounts are correct. However, from 27.09.2025 for a period of 10 days, the employees of our company were not able to tally the accounts since the office was closed due to Durga Puja vacation. Thereafter, on 09.10.2025, when our work resumed, we were astonished to notice that several tickets from SpiceJet Airlines had been created in our system without corresponding invoices or billing records amounting to a sum of Rs.7,97,147/-(Rupees seven lakh ninety seven thousand one hundred forty seven) only. It is pertinent to mention here that the unlawful bookings were done during this period i.e., from 29th September 2025 till 09th October 2025. After noticing the same we immediately contacted our agents enquired about these illegal bookings but to our utter shock they all intimated us that they had not made any such bookings.

Being confused by such bookings, we sent an email to SpiceJet on 09th October 2025 and informed them about the suspected fraud appertaining to which we checked each flight's timing and the names of the passengers associated with these tickets. The said matter was also immediately reported to SpiceJet Airlines, over phone who on its own initiated their inquiry and shared some details of the passengers i.e., mobile numbers of passengers, email id of the passengers, but the email IDs used for bookings were fake. When we called the numbers provided, we learnt that the passengers had obtained the tickets through other, unregistered/ unauthorised agents.

On 11.10.2025, SpiceJet shared booking details with us, including IP addresses and transaction records of the list of passengers. With this information, we were able to compile a list containing the names of passengers, ticket PNRs, transaction amounts, and related data in detail, all of which are enclosed with this complaint. This incident has caused financial loss to our company, and it is clear that someone has misused our systems and the airline's portal for illegal purposes.

In light of these facts, I request you, to investigate the matter, trace the persons using our platform and airline portals to create unauthorised tickets, and take appropriate legal action under applicable criminal laws. I also seek your assistance in recovering the losses suffered by our company as a result of this Received on 16/10/2025 of 15:15 hos.
