Dear Sir,

I, Sri Amrit Chhetri, Son of Late Padam Bahadur Chhetri, resident of Jadubhita, Milan More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling beg to report you that yesterday on 29.10.2025 at about 8.30 p.m. I, being an e-rickshaw man was waiting for passenger at Milan More. One Sonu Darjee, Son of Gange Darjee, resident of Milan More and his 10 to 12 men gang started to burst the crackers. Suddenly some crackers had burst below my e-rickshaw. I just told them to not to throw the crackers towards my rickshaw but in response Sri Sonu Darjee instead of obeying me suddenly attacked on me using his powerful blow and kicks and in the blink of an eye his entire gang man also started to beat me. They were telling me "how dare to direct us where to burst the crackers. Are you a Mastan of Milan More etc. etc." They were continuously beating me and when I fell down on the road all they dragged me towards the nearby shop and they beat me there again till I lost my energy even to cry. Later, they left me hoping that I will be died. A little bit later I somehow managed to contact my wife who came and took me to Siliguri Civil Hospital where I was traeted.

That sir, I am a simple law abiding man being permanent resident of Jadubhita, Milan More whereas Sri Sonu Darjee and his friends are very dangerous men and if any action is not taken against them the entire Milan More area will be affected with their anti social activities.

I therefore humbly requeast you to kindly register the matter stated above as an F.I.R. in your P.S. against said Sonu Darjee and his friends and do the need ful in this regard.
