Sir,

In producing herewith Four (04) accused persons namely (i) Sonam Tamang @ Dawa (27Yrs) S/O Lt. Kumar Tamang of Adarpara, PS Kotwali, Dist Jalpaiguri (ii) Asish Rai (21yrs) S/O Lt. Ramesh Rai of Dewrali, PS Kurseong, Dist Darjeeling (iii) Sushant Rana (22yrs) S/O Sagar Rana of Gurung Busty, Ram Narayan Math ward No 03, PS Pradhannagar, Darjeeling and (iv) Rohit Chhetri (35yrs) S/O Purna Chhetri of Chel Busty, Malbazar PS, Dist Jalpaiguri under arrest along with the following seizure articles viz :- (i) One sharp cutting weapon locally called as "Khukuri" measuring approx 21 inches, (ii) One iron "Hummer" including wooden butt measuring approx 09 inches, (iii) One iron made weapon locally called as "Hasua" measuring approx 23" including its wooden butt, (iv) One iron made "Plus", (v) One iron made house breaking weapon locally called "Sabol" measuring approx 20 inches, (vi) One blue colour "Torch light", and (vii) one multi colour nylon bag.

I, SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted Four (04) arrested accused persons and others 07/08 unknown miscreants who involve in this crime, to the effect that on 30.10.25 at 22.10 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled at the back side of Regulated Market, under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Pokaijote and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vides Pradhan Nagar PS GDE No. 1683 dated 30.10.2025 and informed the matter to you. As per your kind order and direction, I along with ASI Prabal Sarkar, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer ASI Sanjib Mukherjee and requested him to come to Regulated market to accompany us. At around 22.30 hrs we arrived at Regulated Market under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer ASI Sanjib Mukherjee arrived at the spot to accompany us. I shared the information with my raid team and briefed them properly. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Nur Hussain(21yrs) S/O Abdul Halim of Debidanga, Kalkot, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Lal Babu Malakar (19yrs) S/O Basant Malakar of Debidanga, Kalkot, near Petrol pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 11/12 persons were assembled at the buranda of one abandond stall, and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above noted four (04) accused persons while 07/08 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparations for committing Dacoity at Pokajote and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 22:45 hrs. to 23:15 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 07/08 of their associates who fled away, gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Pokajote.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four (04) arrested accused persons namely (i) Sonam Tamang @ Dawa (27Yrs) S/O Lt. Kumar Tamang of Adarpara, PS Kotwali, Dist Jalpaiguri (ii) Asish Rai (21yrs) S/O Lt. Ramesh Rai of Dewrali, PS Kurseong, Dist Darjeeling (iii) Sushant Rana (22yrs) S/O Sagar Rana of Gurung Busty, Ram Narayan Math ward No 03, PS Pradhannagar, Darjeeling and (iv) Rohit Chhetri (35yrs) S/O Purna Chhetri of Chel Busty, Malbazar PS, Dist Jalpaiguri and others 07/08 unknown miscreants who fled away from the spot and arranged for its investigation.
