Subject: Request for Registration of FIR Against Mr. Raj Kumar Biswas and Mrs. Nilma Biswas for Criminal Breach of Trust, Illegal Confinement of Property, Extortion, and Defamation.

I, Ujjal Chaki, Director of Urban Culture Vertex Infrastructure Private Limited, hereby lodge this complaint against Mr. Raj Kumar Biswas and Mrs. Nilma Biswas, residents of Dasparahat (Partly), Dakshin Jibhakata, Chopra, District -- Uttar Dinajpur, West Bengal -- 713207, currently residing in Siliguri, West Bengal.

Our company had taken a premises on rent from the above individuals for office use situated at medical, siliguri. Despite repeated requests, they never provided any formal rent agreement, ownership proof, or legal documentation. Nevertheless, we paid a sum of ₹30,000 as advance rent, which remains unreturned and unaccounted for.

From last few months, these individuals have forcefully and illegally locked the rented premises, denying us lawful access to operate our business for several months. Despite the office being locked and inaccessible to us, they are unjustly demanding the rent for the locked office space for seven months, a demand that is baseless and malicious. Additionally, they have presented an inflated electricity bill of ₹3,500 for the locked office.

Furthermore, they have withheld our company's belongings, including office furniture, laptops, hardware items, and important documents. This unlawful retention of our property amounts to criminal breach of trust. Contrary to their claims, we do not possess the keys to the premises; they themselves have accessed the office freely, as proven by CCTV footage in our possession.

Moreover, they have continuously spread false rumors and issued threatening, defamatory statements against our company. Their deliberate attempts to malign our reputation and provoke others against us have caused significant harm to our professional image, credibility, and goodwill in the market.

In light of the above, I request that an FIR be registered against Mr. Raj Kumar Biswas and Mrs. Nilma Biswas under relevant sections of the Indian Penal Code, including those pertaining to criminal breach of trust, criminal trespass, extortion, defamation, intimidation, and mischief. I
