Dear Sir,

With due respect, I, DR. SHAHIN PARWEEN, daughter of Md Mustakim, wife of Shaba Hussain, resident of Iskcon Road, Sashtri Nagar, Near Bank of India, Siliguri, P.S.- Bhaktinagar, District – Jalpaiguri, W.B.-734001 would like to lodge a formal complaint in the matter of abuse by my husband Shaba Hussain, son of Md Hussain, of Nariyar Road, Naya Bazar, Ward No. 2, Saharsa, P.S. & Dist. – Saharsa, Bihar- 852201. I am married with my husband since 11th November, 2021, as per Muslim rites and customs in the presence of friends, relatives and family members of both the parties. I have a son namely Md. Yusuf Arham, born on 15th October, 2023 out of this marriage.

Since marriage the attitude of my husband was very rude and indifferent. He frequently started taunting me about my colour and complexion and demanding to transfer my salary to his account, as he married me only for my money and my status and started physical assault upon me to silence my voice. It was hard to accept the humiliation inflicted by him upon me.

My husband slapped me firstly in July, 2022 over some pity issue and thereafter frequently on many occasions. On 3rd September, 2022 as a result of excessive mental stress due to ongoing physical, verbal, emotional abuses and not being able to take care of myself because of the ongoing circumstances, I suffered miscarriage and underwent severe trauma due to his act of violence.

Thereafter, when I again conceived in the month of January, 2023 for the second time, he became violent after knowing my pregnancy and tried to destroy the foetus. In an attempt to kill the foetus, my husband, once again abused me by slapping and pressing my neck against the bed of the our room. He tried to kick in my stomach and deliberately attempted to destroy my foetus. While doing such inhuman act he said that he

complexion and my failure to provide dowry and transfer my salary to his account, which being his sole motive to marry me. I, anyhow, managed to free myself from his clutches and came back to my father's house. My husband again took me away from my father's house with a promise that he would not repeat the act of physical abuse and will takecare of me and our unborn baby. But the abuses continued in verbal, emotional and mental forms.

I thought that after the birth of our child, my husband would improve his acts and behaviour and would try to live peacefully but he always maltreated and misbehaved with me and my family members.

I tried my level best for the betterment of the marital abode and also to manage with him and in this regard left no stone unturned. However, on 08th October, 2023, my husband dropped me to my father's house and thereafter he neither came to take me back nor shown any intention to continue the matrimonial relationships with me.

On 14th November, 2023, my husband along with his brothers Dr Shafaque Hussain and Sanower Hussain and thier mother Mrs Shamima Khatoon, tried to kidnap my son in the midnight. He hit me and my family members in pursuit to take away my son forcefully. However, due to timely intervention of Police, I and my son were protected from the violence of my husband.

However, my husband has given me threat that he would take away my minor son from me forcefully and would kill anyone who would come to prevent him from doing such act of kidnapping.

I and my family members are under constant fear of my husband and his associates. Kindly take necessary steps against him and help us to live a safe, peaceful and secure life.

And for this act of your cooperation I shall always remain thankful to you.
