This is to inform you that I, Smt. Mithu Das Roy, wife of- Sri. Gopal Roy, resident of- Madhya Shantinagar, Dabgram- 2, Siliguri, P.O.- Shantinagar, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 734004, presently residing at-Baribhasa, Dabgram- 2, V.I.P. Road, P.O.- Sahudangihut, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 735135, got married to Sri. Gopal Roy on 23.01.2012 in accordance with the Hindu rites and customs, in the presence of our family members at Siddeshwari Kalimandir, S. F. Road, Siliguri. It is pertinent to mention herein that the said marriage was arranged between us through an intermediary/matchmaker. It is also pertinent to mention herein that on 23.01.2012 during the morning when my family members went to the house of said Sri. Gopal Roy for blessing him (Ashirbad ceremony), he was missing from his house, however after calling him several times, he came back in the evening along with his friends and forcefully started demanding that he will either marry that day or he will marry after one year, however, my parents were not willing to get me married after hearing him, but due to strong indulgence from the family members of Sri. Gopal Roy, my parents got convinced and thus I was married to Sri. Gopal Roy on 23.01.2012.

That after the solemnization of the aforesaid marriage, I shifted to my matrimonial house, situated at- Madhya Shantinagar, Dabgram- 2, Siliguri, P.O.- Siliguri, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 734004, and started residing therein with said Sri. Gopal Roy as husband and wife along with his family members consisting of his mother namely- Smt. Shanta Roy, elder brothers- Sri. Dulal Roy and Sri. Manik Roy, eldest brother's wife- Smt. Malati Roy and Smt. Rinku Roy, eldest brother's son- Sri. Debashish Roy.

That after a few days of the said marriage, I started to notice some abnormal behavior in my husband, such as- I was the newly wedded wife but in spite of talking to me or spending time with me, he used to spend time with his eldest brother's wife, namely Smt. Malti Roy, like drinking tea in the morning together, giving tea to his brother's wife, giving the leftover food on his plate to his brother's wife, if he brings something at home he gives it to his brother's wife, etc. However, initially I did not bother about all these, but gradually I came to learn from my mother-in-law and the neighbors that he has an illicit relationship with his brother's wife and when I asked my husband about the same, he even confessed that he has an illicit relationship with his brother's wife. I tried to make him understand and asked him to stop keeping

any relation with his brother's wife, but he started quarrelling with me, verbally abused me with filthy and invective languages and also physically abused me with fists and blows and thereafter he started living separately from me and even stopped sharing the same bed. I informed everything to my parents and they arranged for a meeting and tried to solve the issues between us, but it was of no effect, however, my parents explained to me to stay with him since he was my husband and that slowly and gradually everything would be alright.

That after a few months, I again came to learn that he is in contact with his ex-girl friend namely Anita Sethia and I also found out that he still has physical relation with her and I also found out vulgar text messages in his phone, and when I confronted him, he again quarrelled with me and verbally and physically abused me. It is also pertinent to mention herein that my husband used to mentally and physically torture me even on small and petty matters and rather tried to portray that I have extramarital relationships despite knowing well that it is completely false, and he even put GPS tracker on my scooty and always used to keep tabs on me. It is also pertinent to mention herein that on one occasion, a friend of mine who I got acquainted through facebook, once insisted me for help, who is a national of Bangladesh, who had come for his treatment purposes, and as such I helped him by making an appointment with the doctor, and when I went to his house to give him the documents related to his treatment, my husband also followed me there and made a scene out of it proclaiming that I have relationship with that man.

That it is also pertinent to mention herein that even after my marriage, I wanted to complete my graduation, but due to pressure from my husband and in-laws, I had to give up on my studies. Furthermore, my husband and in-laws also brought false allegations against me, proclaiming me to be a thief and characterless lady concerning various incidents that took place in our household and on several occasions, they also called my parents and brothers to their house and insulted them.

That out of the aforesaid marriage, two children were born, namely Miss Gunjan Roy on 07.08.2014 and Master Samiran Roy on 03.12.2019. It is pertinent to mention herein that the children wanted to spend time with their father, but he always neglected them and never took proper care of them. My son is suffering from autism, and my husband on several occasions has even expressed his displeasure to treat his son.

That due to mental and physical abuse and the domestic violence hurled upon me and the differences that had cropped up between me and my husband, I was unwilling to stay at my matrimonial house and in the month of March, 2025 my husband informed me that he was going out of station for work and as such he forced me to go back to my parental home along with the two children and thereafter he never came to take me back or even came to meet me or the children. It is pertinent to mention herein that all that

streedhan properties, relevant documents and clothes are in the custody of my husband at the matrimonial house. Furthermore, at present, he is neglecting to maintain me and also our children. Furthermore, my husefficer in charge has opened his business in my name and has also obtained the licenseastichar out possaid business in my name and he has been running the said business atticker Bhaktinagar P has also purchased property in my name from the monetary help given to the Bhaktinagar P by my brothers and parents and at present he is fraudulently trying to grab hold of the said properties by pressurizing me. Moreover, for almost a period of two years during 2021-2023, he even engaged me in his business, but never paid any remuneration to me.

That on 28.09.2025, my daughter Miss Gunjan Roy called my husband so that she could bring her new pair of shoes which she had bought for wearing during the festive season from the money taken from me and when she went to my matrimonial house, she found that the room was all messed up and when my daughter questioned her husband about the same, he locked her up in a room and started beating her and also made video recording of the same, however, my daughter started shouting and when my in-laws and the neighbors came, she somehow managed to save her life and escape. However, since he was my husband, I did not want to take any adverse action against him and still wanted to lead a happy and peaceful marital life and tried my level best, but all is in vain. It is also pertinent to mention herein that after the said incident my daughter was extremely traumatized as to how her father could behave with her in such a manner.

That under the aforesaid facts and circumstances, I, hereby request you take appropriate action against the aforesaid Sri. Gopal Roy and ensure that justice is served. Your swift action in this matter will help protect my rights and interests.
