With due respect I, Smt. Kavita Dhanuka, Wife of Sri. Gagan Dhanuka, daughter of Sri. Girdharilal Khemka, presently residing at Block - 5, Lobby - 1, Flat No. 1, 2nd Floor, Green Valley Apartment, Upper Bhanunagar, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri beg to state that I have entered into marriage with Sri. Gagan Dhanuka, Son of Late Jugal Kishore Dhanuka, presently residing at "Dolphin Signature", 5th Floor, A-Block, Near Lions Blood Bank, Jyotinagar, P.S. Bhaktinagar, Dist. Jalpaiguri and our marriage was solemnized on 10/07/1999 at Sree Ram Paradise, Agrasen Road, Khalpara Dist. Darjeeling according to Hindu Rites and Customs.

That after solemnization of the marriage, my husband took me to his house and we have started to live together as wife and husband and in the meantime out of our wedlock, one male child namely Dev Dhanuka was born (now aged about 25 years) and one female child namely Prapti Dhanuka was born (now aged about 20 years). During stay in the matrimonial house, I came to know that my husband have several illicit relationships but despite of the fact I did not raise question for the sake of my children, although during such stay with my husband, he used to misbehave with me on several occasions and he started to neglect me and by creating difficult situations he always abused me. In all times, I have tried to adjust with my husband with a faith that he will rectify himself and will become a responsible husband as well as a responsible father of my children. After expiry of some times, I found that my husband used to come to the house in drunken conditions and even after my protest, he did not stop and he used to assault me in front of my children in intoxicated condition.

In the month of April 2012, my husband took me and my children in the above mentioned flat at "Green Valley Apartment" which is in the name of my husband and his brother Sri. Arun Dhanuka and subsequently my husband entered into real estate business but since the year of 2022, I came to know that my husband has engaged himself in an illicit relationship with one namely Smt. Madhu Bharatia, Wife of Sri. Rohit Bharatia, resident of Gate No. 4, A-17, near Bread Line Circle, behind Mayor Bungalow, Sai Ashish Society, New City Light, Althan, District Surat, Gujarat and since then I have repeatedly noticed that my husband has significantly increased the alcohol consumption and when I tried to request him not to take any more, he abused me in filthy language and thereafter he started to live in a separate room and when I have questioned him why he is doing so, he completely neglected me without any just cause except his illicit relationship.

Thereafter following such inhuman torture on 08/05/2024, when I resisted my husband and raised strong objection, he left the flat by saying that if I will stop him then he will kill me and after that my husband started to reside at "Dolphin Signature", 5th Floor, A-Block, Don Bosco Colony, Near Lions Blood Bank, Jyotinagar, P.S. Bhaktinagar, Dist. Jalpaiguri and said Madhu Bharatia used to stay with my husband and they have been visited several hotels together and they have started travelling to various

destinations and I came to learn about all of this facts when I have found some joint pictures of my husband with said Madhu Bharatia which were uploaded in social media by my husband. Recently, I came to know that my husband has misappropriated my money from my bank accounts and he has also taken various loans in my name.

Everyday he has been threatening me and asking me to quit and vacate the aforesaid flat with my son and daughter and on the other hand. Since last few days my husband has been forcing me to sign in some blank papers for his illegal gain and threatening me that if I will not sign on such papers he will forcibly oust me from the aforesaid flat. Moreover, my husband has not been paying any maintenance or day to day expenses to me.

Therefore, I request you to take necessary legal action against my husband Sri. Gagan Dhanuka, Son of Late Jugal Kishore Dhanuka, presently residing at "Dolphin Signature", 5th Floor, A-Block, Don Bosco Colony, Near Lions Blood Bank, Jyotinagar, P.S. Bhaktinagar, Dist. Jalpaiguri, mobile no. 9832043184, 7001558948 and said Smt. Madhu Bharatia, Wife of Sri. Rohit Bharatia, resident of resident of Gate No. 4, A-17, near Bread Line Circle, behind Mayor Bungalow, Sai Ashish Society, New City Light, Althan, District Surat, Gujarat. And for this kindness, I shall much oblige to you.
