Subject: Written complaint regarding continuous harassment of my daughter and a recent violent attack on my sons by Debu Barman, his friend Md. Jainur and his family members.

- o Gouri Barman, mother of Debu Barman
- o Deba Barman, brother of Debu Barman
- o Bindiya Barman, wife of Deba Barman
- Md. Jainur, friend of Debu Barman

Respected Sir,

With due respect, I Ram Briksh Mahato, Son of Late Ram Dayal Mahato, resident of Satyajit Nagar, near Tea Auction Road, Shani Mandir, P.S. Pradhan Nagar, Dist. Darjeeling, am lodging this written complaint against my neighbour Debu Barman and his family members for continuously harassing my daughter and for a brutal assault on my two sons this evening.

I would like to inform you that, My daughter, who is now aged about 18 years old, had been continuously harassed and stalked for a long time by Debu Barman when she was minor, who lives in the same locality. He used to follow her on the roads and harass her whenever she went out. In 2023, I had gone to the police station to lodge a written complaint, but upon the request of some local people and community members, I withdrew the complaint as Debu and his mother apologised publicly and promised not to repeat such behaviour. However, after some time, he again started stalking and harassing my minor daughter. He even threatened that he would forcibly take her away from home and sell her. Because of this constant harassment and threat, I had to stop my daughter's education and keep her confined at home for safety.

I would like to further inform you that, today evening, at about 6:00 PM, my younger son Sujit Kumar Mahato (aged about 16 years) was returning home after playing cricket. Suddenly, Debu Barman and his friend Md. Jainur stopped him on the road, threw him to the ground, and started beating him badly. They held him by the neck and attacked him with a sharp weapon, causing an injury on his hand. When my elder son Amit Kumar Mahato rushed to the spot after hearing about the incident, both accused persons also attacked him and beat him up.

Thereafter my elder son saw that my younger son's hand was bleeding due to a knife cut. They immediately took him to a nearby medical shop for first aid. While there, the same accused persons again attacked with an iron object, hitting him hard on the head with an intention to kill. My son suffered a deep head injury with profuse bleeding and

fell unconscious on the ground. Locals rescued him and took him to Siliguri Hospital, where he received three stitches on his head. The entire assault incident was captured in the CCTV footage of the said medical shop under the name and style M/S. Sanjeevni Medical Hall.

I would like to further inform you that, after the incident, I went to the said medical shop to inquire about the matter. At that time, Debu's mother (Gouri Barman), his elder brother (Deba Barman), and his father (Dukhu Barman) together caught and hold me by the neck and brutally assaulted me as well. They threatened to kill me and my family if I reported the incident to the police.

I would like to request you to register an FIR against all the accused persons mentioned above under appropriate sections of law and take immediate and strict legal action against the culprits for harassment, criminal assault, and attempt to murder and also provide protection and safety to my daughter and my family, as we are under constant threat from the accused family and kindly investigate the matter thoroughly and ensure that the culprits are punished as per law.
