Subject: Written complaint regarding physical assault, threat to life, and snatching by Sumit Kumar, Amit Kumar Mahato, and others

Respected Sir,

I, Gouri Barman, wife of Durjhe Barman, resident of Mallaguri, Tea Auction Road, Siliguri, beg to state the following for your kind information and necessary action.

That on 30th October 2025, at about 6:30 PM to 7:00 PM, my son Debu Barman along with his friend Md. Jainul were walking at Green Park, Siliguri. During that time, a group of boys, namely Sumit Kumar, Amit Kumar Mahato, and some others whose names are not known to me, came near them and started using abusive and vulgar language about my son's wife. When my son objected to their behaviour, one of the accused slapped him.

My son, in self-defence, pushed that person. At this, they got angry and threatened him by saying, "Tu yahi ruk, aaj tujhe jaan se maar dunga," and then they left the place.

After a short while, the same persons returned and attacked my son. One of them hit my son's face with a bike key, causing injury. When Md. Jainul tried to take out his mobile phone, they snatched his phone and also took ₹2000 which was kept inside the mobile cover. They also snatched an 8-gram gold chain from my son's neck.

They beat my son and his friend badly with fists, blows, bamboo sticks, and lathis. One of them also hit my son with an iron rod, due to which he became half unconscious. When Jainul tried to save him, he too was beaten severely.

Hearing the noise, local people gathered at the place and rescued both my son and his friend. I then reached the spot and immediately took my son to Sanjivani Nursing Home for emergency treatment. However, even at the hospital, those persons again came and tried to attack my son.

Fearing for my son's life, I shifted him to the Siliguri District Hospital, where he is still admitted for treatment. He has received four stitches on his face and has suffered serious injuries.

The said persons not only attacked my son but also snatched his gold chain and cash. They have continuously threatened to kill him, and we are in fear for our safety.
