Subject: FIR against a person for creating nuisance, causing physical injury, abusing and assaulting women, and defaming the club during Kali Puja at GTS Club, Hakim Para.

Respected Sir/Madam,

I, Sri Rishav Gupta, Son of Sri Sanjay Gupta, residing at Bhutia Market, Hakimpara, wish to lodge this complaint against **Summit Saha**, Ph: **7337896170**, who created severe nuisance and engaged in violent, abusive, and indecent behaviour during the Kali Puja festival held at GTS Club, Hakim Para, Bhutia Market, Siliquri.

That on 23rd, October, 2025 at around 12.30 Am, the said person forcefully entered the premises of GTS Club during the festive celebration, created public nuisance, used abusive and filthy language, and physically assaulted certain members of the organizing committee and attendees, including women. They caused physical injuries to several persons and also abused women both physically and mentally, by touching them inappropriately, tearing their clothes, and behaving in a highly indecent and offensive manner.

Despite repeated requests, mediation efforts, and peaceful settlement attempts from our end, including intervention by local respected persons and the Councilor of the concerned ward, the said person continued their wrongful acts for two consecutive days thereafter, again entering the club premises and creating further nuisance, intimidation, physical assault, and misbehaviour towards women, thereby causing immense panic and disruption to the festival and the public present there.

The Councilor of the ward had helped to control the situation and assured that the matter would not be escalated further, and on the basis of such assurance, no immediate formal complaint was made. However, to our utter shock and dismay, the said person later filed a false and fabricated FIR against our members, attempting to malign our image and misrepresent the true facts of the incident.

Further, the Said Person has gone to the extent of defaming the GTS Club and its members by publishing false and malicious allegations in a local newspaper, thereby damaging the club's reputation and goodwill in the community. In view of the above, I request you to kindly register this complaint as an FIR and take necessary legal action.

I further request you to investigate the matter thoroughly, record statements of the victims and witnesses present during the incidents, and take appropriate steps to ensure justice and prevent such unlawful acts from recurring in future public gatherings.

Enclosed herewith are copies of relevant documents and the newspaper publication evidencing the act.
