I, SI Kalachand Mandal of Khalpara TOP-II, Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 01 (one) arrested accused person namely herewith Sushanta Biswas (26 yrs) S/O Late Nikhil Biswas of Chaklda, Sanyalchar, PO- Natunpara, PS- Chakda, Dist- Nadia (Not verified) to the effect that today i.e on 31.10.2025 at about 19.05 hrs received a specific source information that 01 (one) person was standing possessing huge quantity of narcotic substances Ganja to sell the same to their designed customers at Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist-Darjeeling. The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No. 1747 Dated- 31.10.2025 and subsequently, I informed the matter to the Inspectorin-Charge, Siliguri Police Station in written and being directed, myself along with ASI Sushanta Sarkar, ASI Subir Sen, ASI Rabin Lama, ASI Debasish Das, C/160 Soumen Sarkar all of Siliguri PS, SPC and along with investigation kit left for Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist-Darjeeling by Govt. aided vehicle having Registration No-WB24K/7669, driven by CD-1148 Sudipta Nandi to verify the veracity of the source information. This refers to Siliguri PS GDE No. 1748 Dated- 31.10.2025 and M.C.C No-1061 31.10.2025. I also informed cameraman namely Pradip Kr. Paul (60 yrs) S/O Late Jogannath Paul of NJP, Bhaktinagar, PS- NJP, Dist- Jalpaiguri (9832049445). Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist- Darjeeling, I contacted two persons namely 1) Mukesh Mandal (34 yrs) S/O Sri Ganay Mandal of Hemanta Basu Colony, Ward No. 04, PS- Siliguri, Dist- Darjeeling, 2) Gopi Sahani (27 yrs) S/O Okil Sahani of Rana Busty, Subhashpally, Ward No. 18, PS- Siliguri, Dist- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist- Darjeeling at 17.25 hrs. Being identification by source we cordoned the place and managed to apprehend the said person. On being asked he disclosed his identity as noted above and after detaining we found that the said apprehend person was sitting on a Big Colour Plastic Sack. Thereafter, we disclosed our identity and informed him regarding the information in hand and stated him that he will be searched in person for the said purpose.

The above noted apprehended person admitted that he have illegally possessed Ganja without any valid license for selling the same to his designed customers as per his requirement. I then gave them option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazzetted Officer and they agreed to be searched in presence of any one of the above. As the time was odd and also time period of doing all required process is already overcharged. Hence, I informed the fact to Shri Prasenjit Biswas, Inspector -incharge, Siliguri Police Station to act as a Gazetted Officer regarding interception of the accused person suspected to be possessed illegal Ganja and requested him to come at Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist- Darjeeling to remain present and to supervise the search and Accordingly, Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived at the spot i.e Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist- Darjeeling as Gazetted Officer. Then, I offered the independent witnesses and the accused person to search our police party as per provision of law but he did not search the police party but as per instruction of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer personal search of our raiding party and our vehicles was conducted but nothing incriminating was found. A nil search list to that effect was prepared. Thereafter in presence Shri Prasenjit Biswas, Inspector -incharge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained person namely Sushanta Biswas (26 yrs) S/O Late Nikhil Biswas of Chaklda, Sanyalchar, PO- Natunpara, PS- Chakda, Dist- Nadia following all formalities, keeping his decency and recovered 1) One transparent plastic carry bag containing 2.075 kgs of Ganja , marked as "Exhibit- A" , 2) one packet wrapped with Brown Colour cello tap containing 4.875 kg of ganja, marked as "Exhibit- B" ,3) one packet wrapped with Brown Colour cello tap containing 4.840 kg of ganja, marked as "Exhibit- C", 4) one packet wrapped with Brown Colour cello tap containing 2.860 kg of ganja, marked as "Exhibit- D" 5) one packet wrapped with Brown Colour cello tap containing 3.235 kg of ganja, marked as "Exhibit-E", 6) one packet wrapped with Brown Colour cello tap containing 4.495 kg of ganja, marked as "Exhibit- F", 7) One Big white colour plastic Sack, marked as Exhibits-G [Articles noted in Sl. No. 1 to 6 were kept concealed in Sl.No. 7) which was recovered from the exclusive and conscious possession of Sushanta Biswas (26 yrs) S/O Late Nikhil Biswas of Chaklda, Sanyalchar, PO- Natunpara, PS- Chakda, Dist- Nadia (Not verified).

Further, on demand in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses the above noted detained person failed to produce any valid documents in support of possessing of such contraband. Being further interrogation, the accused person noted above admitted in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that he has procured the above noted illegal Ganja clandestinely for the purpose of selling the same in high rate to his designed customers for his personal gain by illegal means. He Ganja illegally for last few months for his wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted accused person at the spot at Beneath the under construction bridge near Jhankar more opposite to TVS showroom, ward no. 04, PS- Siliguri, Dist-Darjeeling under proper seizure list in presence of Shri Prasenjit Biswas, Inspector –incharge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labeled the seized articles in presence of Shri Prasenjit Biswas, Inspector –in-charge, Siliguri Police Station acting as Gazetted Officer and independent witnesses as noted above. The whole process of seizure and label was made in between 21.35 hrs to 22.55 hrs on 31.10.2025. The whole process of Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Sushanta Biswas (26 yrs) S/O Late Nikhil Biswas of Chaklda, Sanyalchar, PO- Natunpara, PS- Chakda, Dist- Nadia (Not verified) are involved in procuring and selling of Ganja illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused persons after observing all the formalities and informing the ground of his arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused person namely Sushanta Biswas (26 yrs) S/O Late Nikhil Biswas of Chaklda, Sanyalchar, PONatunpara, PS- Chakda, Dist- Nadia (Not verified) and arrange for its investigation.
