Siliguri, Dist. Darjeeling would like to state that I am engaged in the business of wholesale and retail sale of electrical goods having my shop room situated in the address mentioned above since a long and I have a godown measuring about 4000 sq.ft (Four Thousand Square feet) approximately in the aforesaid building comprising three floors. That one Pradip Das is a staff at my shop and was working from past 10 years. I store my goods purchased for my business in the godown as mentioned above and prior to 3years I have been witnessing some anomality and/or irregularity in my stock of goods stored in the godown and was unable to find out the reason for the same and after resumption of regular business subject I have been noticing the aforesaid irregularity and anomality in my stock on regular basis each month and there is always difference in the stock purchased and sold by me more or so particularly in products such as Wires of different widths, quality and quantity, Motor Starter (Various Brands), Fan Regulators (Various Brands), Isolators (Various Brands).

It is pertinent to mention here that CCTV cameras is installed in my godown and as I was witnessing the anomality and/or irregularity in my stock on regular basis I started observing the video footage of the CCTV Cameras installed both live as well as recordings and I could find out that one of my staff Pradip Das, Son of Haripada Das, resident of Champasari, Daknikata(P), P.O. Pradhan Nagar, P.S. Pradhan Nagar, Dist. Darjeeling who is employed in my shop since 10 years has been stealing/theft away my goods from my godown. The incident of stealing/theft away of goods have been caught and recorded in the CCTV cameras. That after discovering the same I have thoroughly made a scrutiny of my accounts and the amount of stolen/theft away goods from the period of May 2022 to September 2025 amounts to Rs. 20,52,845/- (Rupees Twenty Lakhs Fifty Two Thousand Eight Hundred and Forty Five only).

While Interrogating Pradip Das, he confronted that he has supplied the materials to Samir Roy, owner of M/S Lokenath Electric situated at Pradhan Nagar, P. O. Champasari, P. S. Pradhan Nagar, Dist. Darjeeling.

Under the above circumstances I hereby lodge this complaint against Samir Roy Owner of M/s. Lokenath Electric and the aforenamed Pradip Das who have as per the directions, instructions, advice and connivance with said Samir Roy have theft away/stolen goods from my godown in the said building and Samir Roy have further sold/disposed off the said goods knowing full well that the same is stolen and would request you to investigate the matter so that the aforenamed wrong doers can be punished as per law and I am ready and willing to assist in the investigation in any and every manner possible
