2. My wife called me subsequently and informed me that the accused persons attempted to assault her. When I came to the scene/confronted them, the accused persons physically attacked me. They forcibly snatched my Gold chain from my neck and assaulted me with blows. I have received vigorous injuries to my head, chest and arms.
3. The assault was violent and provoked. The accused persons. The assault caused Pain, bleeding. My wife also threatened during the incident.
4. I believe the assault and theft were intentional and malicious. The accused are known to me.
