Sub: Theft of ATM card and Fraud Transaction

Respected Sir/Madam,

I, SHUKLA ROYCHOUDHURY, w/o LATE KUMAR ROYCHOUDHURY,
residing in 37, Sister Nivedita Road, Pradhan Nagar, Siliguri,
would like to inform you that my daughter, MOUMITA GUHA,
had gone to the SBI ATM Gunning Basti to withdraw money
with my ~~de~~ Debit Card today (02/11/2025) at 9:50 am.
After withdrawing ₹10,000/-, my Debit card got stuck in
the ATM.

A person who was waiting outside showed my daughter
a piece of paper with phone number written on it inside the
cubicle, which was apparently a helpline number in case of any
Emergency. The person on the call asked her to fetch the
engineer from the SF Road ATM, who would help her retrieve
the ~~A~~ Debit card, and asked her to not disconnect.

As soon as my daughter left the ATM for SF Road, money
started ~~to~~ getting deducted from my account. By the time
she could block the card, ₹1,80,000/- was deducted.

I request you to please lodge an FIR for this theft and
fraud transaction.
