Sir,

I, Ranadip Mazumder, S/O :-Late Kalipada Mazumder , AE & Station Manager, Powerhouse CCC , WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 01.11.2025 at Kalchakra Road , Salugara, Dis:-Jalpaiguri, which I believe warrants immediate attention and investigation. The incident involved an accident by a Truck (Bearing no:- WB73/F9156) with our electrical installations, that caused significant damage to WBSEDCL's property and public safety. As result of the accident, conductor snapped of LTOH network along with other damages caused power related issues at the said localities.

As information received from the accident location at 8:25 PM, our technical team attended the spot immediately at 8:40 PM and noticed snapping of conductor occurred on LT OH along with other electrical installations due to the accident with the said Truck. Our technical team rectified the fault immediately and restored the electricity at about 9:05 PM and left the site. The Truck was found at the site.

The total financial losses caused due to this accident are approximately Rs. 3700.00 (Three Thousand Seven Hundred) only.

Given the potential risks and financial implications, I kindly request you that a FIR be registered regarding this accident against the said Truck No:- WB73/F9156. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property. This is for your kind information and further needful action please as per law.
