Sir,

I, Smt. Sanchayita Ghosh, W/O- Lt. Shamik Ghosh, R/O- Rasbihari Sarani, Hakimpara, P.O and P.S- Siliguri, Dist- Darjeeling beg to inform you that after the sad demise of my husband a Deed of Partnership dated 31st day of March 2015 was executed between me and two other persons namely Smt Manju Sri Sukumar Ghosh and one Sri Gourav Ghosh S/O- Sri Ghosh, W/O-Sukumar Ghosh both R/O- Rasbihari Sarani, Hakimpara, P.O & P.S- Siliguri, Dist- Darjeeling. The said partnership firm was constituted under the name and style "Prabhu Bhog" for carrying the business of manufacturing and trading in sweets, snacks etc. That the said partnership business is running from Ghosh brothers building situated at Bidhan Road, Bidhan Market P.O & P.S- Siliguri, Dist- Darjeeling, and I being a partner of the said partnership business was entitled for 50% of profit or loss determined at the end of every year and also entitle for a sum of Rs. 50,000/-(Rupees Fifty Thousand Rupees Only) per month as a monthly remuneration from the said partnership business.

Since, after execution of the partnership agreement the remaining two partners in connivance with Sukumar Ghosh, S/O Lt Sudhir Ch. Ghosh R/O-Rashbihari Sarani, Hakimpara, P.O. and P.S-Siliguri, Dist-Darjeeling, who is the husband of Smt. Manju Ghosh and the father of Sri Gourav Ghosh are always avoided me and never furnished any accounts of the said partnership business. It is pertinent to mention here in that since 31st day of March 2015, I never received any monthly remuneration of Rs. 50,000/- (Rupecs Fifty Thousand only) from the partnership business. The said partnership business

was initially run successfully in associate with the said Sukumar Ghosh, but the remaining partners are never furnished any profit and loss account to me since from the inception of the partnership business and also not paid any monthly remuneration to me and the entire profits and my monthly remuneration has been converted in their own and therefore, the remaining two partners including said Sukumar Ghosh intentionally, dishonestly cheated me financially and they also converted my valuable amount in their own.

That in the mean time I, came to know that Gourav Ghosh and Smt. Manju Ghosh have converted the business of manufacturing and trading in sweets, snacks etc into a grocery shop and are running a business under the name and style "Prabhu Bhog" (the mega super market) from the same premises. It is to state that they have converted the partnership business without my permission and are running the business as buyer, sellers, traders, manufactures, marketing, imports, exports, agents and other groceries items etc. That on being further inquiry I came to know that they have executed another Deed of Partnership between them without giving any information to me or without dissolution of the partnership firm. I have been removed from the partnership firm illegally that was duly constituted on 31st day of March 2015. It is to state that Gourav Ghosh and Smt. Manju Ghosh have diverted the entire profit of "Prabhu Bhog" and syphoned my entire monthly remuneration (since 2015) in the business of "Prabhu Bhog" (the mega super stores).

That Gourav Ghosh and Smt. Manju Ghosh under the instigation and in conspiracy with Sukumar Ghosh, without dissolving the partnership firm namely "Prabhu Bhog" syphoned the entire profit and my remuneration in the business of "Prabhu Bhog" (the mega super market) dishonestly with malafide intention to cheat me. Gourav Ghosh and Smt. Manju Ghosh and Sukumar Ghosh fraudulently converted the partnership business to another business by executing forged document and obtained Trade License and the fraudulent document was used intentionally for the purpose of cheating, criminal breach

of trust and cheating. I have been trying to address my grievances for long before various forums but have not received justice. Gourav Ghosh and Smt. Manju Ghosh and Sukumar Ghosh have continuously ignored to give me my entitlements and have openly asserted recently that they will not give me a penny and that if Ii take recourse of law I will be faced with dire consequences.

Therefore, it is requested to your kind office to kindly take the appropriate legal steps against for the illegalities committed by Sri Gourav Ghosh and Smt. Manju Ghosh and Sukumar Ghosh all residing at Rasbihari Sarani, Hakimpara, P.O & P.S- Siliguri, Dist- Darjeeling as book them as per relevant provisions of law.
