Subject: FIR regarding a road accident caused by vehicle No. SK01PF2223 that hit my Scooty No. WB73M6947 near St. Mary's School, Pradhan Nagar.

Respected Sir,

I, Mrs. Poonam Thapa, D/O Arun Thapa, resident of Patimil, Matigara, District Darjeeling, West Bengal (PIN 734010), would like to lodge this complaint regarding a road accident that occurred on 02.11.2025 at about 2:15 PM near St. Mary's School, Pradhan Nagar, Siliguri.

At the said time, I was riding my Scooty bearing registration number WB73M6947 towards my destination when a Honda Car bearing registration number SK01PF2223 came at high speed and hit my vehicle from the side in a rash and negligent manner. Due to the impact, I fell on the road and sustained serious injuries on my left wrist, left knee, and right ankle.

I was immediately taken to Manipal Hospital, Pradhan Nagar, where I received emergency medical treatment. The attending doctors confirmed trauma injuries and an undisplaced fracture of the distal end radius (left wrist), as mentioned in my Emergency Discharge Summary and Outpatient Record issued by Manipal Hospital.

The offending vehicle SK01PF2223 was found parked near the spot in a damaged condition, while the driver of the said vehicle fled from the scene after the accident.

I therefore request you to kindly register an FIR against the driver/owner of vehicle No. SK01PF2223 under the relevant sections of law for rash and negligent driving causing injuries, and take appropriate legal action as per law.
