

- 1. That the Complainant is a peace loving and law-abiding citizen of India.
- 2. That the Complainant states that
 - (i) Smt. Reha Devi Agarwal, wife of Sri Sajjan Agarwal,
 - (ii) Smt. Manju Devi Agarwal, wife of Sri Om Prakash Agarwal,
 - (iii) Smt. Saroj Devi Agarwal, wife of Basant Kumar Agarwal,
 - (iv) Smt. Reshmi Devi Agarwal, wife of Sri Raj Kumar Agarwal (hereinafter referred to as the "PURCHASERS" for the sake of gravity), all are residents of Punjabi Para, Radha Kunj, opposite Shiv Mandir, beside City Mall, Post Office: Siliguri, Police Station: Bhaktinagar, District: Jalpaiguri, Pin Code: 734001 purchased a plot of land



measuring 1.1348 Acres appertaining to and forming part of R.S. Plot No. 2/90, 2/92, 2 & 10/108 corresponding to L.R. Plot No. 210 recorded in R.S. Khatian No.119 corresponding to L.R Khatian No. 2125, 2126, 2127, 2128, J.L No. 02, Sheet No. 04, Pargana-Baikunthapur, Mouza-Dabgram, BL & LRO: Rajganj, District: Jalpaiguri, vide Deed No. I-158



- 3. That thereafter, the names of the purchasers were mutated vide Mutation Case No. IX-11/42491/02-03 in the record of rights.
- 4. That during the L.R. survey, the Land Revenue Officials recorded the name of the purchasers in L.R. Plot No. 210 after recording their names in Math Khosra.
- 5. That thereafter, on application being made by the purchasers, the characters of the land were changed from Sohori to Gudam, and to that effect, conversion certificates were issued in their respective names.
- 6. That on 30.06.2025, the purchasers came to know that the abovenamed accused persons along with their associates kidnapped two of their security guards from the said land and tried to illegally gain possession of the same.
- 7. That on enquiry, they came to know that, these aforesaid Accused Persons in connivance with one staff of BL & LRO, Rajganj namely i. Joydeb Roy Choudhury and Block Land & Land Reforms Officer, Rajganj and other staffs of BL & LRO, Rajganj removed the area of land from the records of rights of the purchasers.
- 8. That the aforesaid persons, on the basis of false and fabricated documents showing the aforesaid purchasers as subsequent sellers manipulated the records of rights issued in the name of the purchasers.



- 9. That later, the purchasers obtained the certified copies of the order dated 05.03.2025 the Mutation Cases sheets being MN/2025/0701/5699, MN/2025/0701/5700, MN/2025/0701/5701, MN/2025/0701/5703, MN/2025/0701/5705, MN/2025/0701/5706 from the office of B.L.& L.R.O. Rajganj, and on perusal of the said order sheets, it transpired that, the names of said 1.Sri Falin Roy, 2.Sri Kamakhya Chandra Paul, 3.Sri Bajaru Roy, 4.Sri Ghatalu Roy, 5.Sri Bidhan Chandra Biswas and 6.Sri Bubai Poddar has been recorded in the L.R. record of rights in place of the names of the purchasers in respect of L.R. Plot No. 210, Mouza- Dabgram, Sheet No. 4, J.L. No. 2, P.S. Rajganj, Dist. Jalpaiguri and separate L.R. Khatians were opened in their names being L.R. Khatian No. 3356, 3341, 3334, 3332, 3355 and 3342.
- 10. That it was further transpired that in doing so no notices whatsoever were served upon the above-named purchasers but the accused persons manipulated with the records, falsely impersonated the purchasers, and showed their presence at the time of hearing and moreover also submitted manufactured "No Objections" on behalf and in the names of the purchasers.
- 11. That subsequently, on 31.07.2025, some of the above named purchasers namely, Saroj Devi Agarwal and Manju Devi Agarwal had written two separate letters to the B.L. & L.R.O. Rajganj thereby requesting him to supply documents viz., Copy of petition filed by the applicant, transfer documents, notices issued on 26.03.2025, service return of such notice, Haziras filed by Saroj Devi Agarwal and Manju Devi Agarwal, investigation report, no objection filed by Saroj Devi Agarwal and Manju Devi Agarwal, field verification report, authority in favour of Joydeb Roy Choudhury in respect of Mutation Cases no. MN/2025/0701/5705 and MN/2025/0701/5699 respectively.


It is pertinent to mention here that despite such requests, no copy of the aforesaid documents as asked by Saroj Devi Agarwal and Manju Devi Agarwal in their letter dated 31.07.2025 have been provided to them till date for the reasons best known to B.L.& L.R.O. Rajganj.



12. That one **Sonam Rumba** who is an officer of the B.L. & L.R.O., Raigard had sent an order sheet dated 28.07.2025 to the complainant through whatsapp whereby, it, inter alia, came to their knowledge that the in the last week of July, 2025 the B.L.& L.R.O. Office, Raiganj received informal allegations regarding legitimacy of transfers of mutation case nos. MN/2025/0701/5699, MN/2025/0701/5700, MN/2025/0701/5701, MN/2025/0701/5703, MN/2025/0701/5705, MN/2025/0701/5706 and a search was ordered and three days later files were recovered from the ladies bathroom of the office of B.L.& L.R.O. Raiganj and the 'No Objection Letters' the primary documentary foundation of the mutations were missing from the case record.

- 13. That that aforesaid Accused Persons namely
 - (i) Sri Falin Roy,
 - (ii) Sri Kamakhya Chandra Paul,
 - (iii) Sri Bajaru Roy,
 - (iv) Sri Ghatalu Roy,
 - (v) Sri Bidhan Chandra Biswas,
 - (vi) Sri Bubai Poddar along with Joydeb Roy Choudhury, B.L. & L.R.O. Rajganj and other officers of the B.L.& L.R.O. in connivance with each other had manufactured documents including the 'No Objection letters' and had committed serious offence of forgery and manipulation of government records for their ulterior motive and illegal gain.
- 14. That on 10.09.2025 the Complainant as per the provision of Section 173 (1) (ii) of the Bhartiya Nagarik Suraksha Sanhita, 2023 made electronic communication to Rajganj Police Station and Superintendent of Police, Jalpaiguri and on 13.09.2025 went to the Rajganj Police station to sign the same but the police officials refused to get the complaint signed by the complainant and register the same as FIR.
- 15. That after the said electronic communication, neither any investigation was made by police nor any F.İ.R has been registered till date and the concerned police officers are avoiding to perform their duty deliberately and they are adamantly not taking any actions against the Accused Persons responsible for committing the offences as stated above. Therefore, it is necessary for this Ld. Court to direct the Inspector-In-





charge, Rajganj Police Station to register a FIR against the Accused Persons as per law.

- 16. That the offences have been committed within the territorial jurisdiction of this Ld. Court, and therefore this Ld. Court has jurisdiction to entertain this application and take cognizance in this matter as the Inspector-In-charge, Rajganj Police Station and Superintendent Of Police, Jalpaiguri have failed to perform their statutory duties which they are obligated to and direct the Inspector-In-charge, Rajganj Police Station to start specific case against the Accused Persons.
- 17. That after exhausting all the possible manner to get the complaint registered and miserably failing to do so, the Complainant is moving this application under the provision of Section 175(3) of the Bharatiya Nagarik Suraksha Sanhita, 2023.
- 18. That the facts as stated in the Petition clearly states cognizable offences committed by the Accused Persons and they should be booked under the relevant provisions of law and this complaint be treated as FIR.
- 19. That this petition is made bonafide for the ends of justice.
