Respected Madam,

Kindly note that a very horrifying incident occurred yesterday at 6.20pm in Tyoti Nagar. I was walking along with my husband on the government Kaccha road near St Michael's school for girls situated in Tyoti Nagar, Sevoke Road. Bakti Nagar ps.

An unknown person approached me on his bike. He parked his bike and came towards me and said "What is your rate? Come with me." (Rate kya hai tumhara. Chalegi kya?) He did not know my husband was also there in the side. After seeing my husband he approached towards him aggressively and started asking our details like name, residence, why we come here. When we refused to tell him anything he started accusing us of theft. He has also given us life threat warning that he will kill us next day (03 Nov 2025). I'm very scared from that time as I also have an 18 year old

daughter at home. He mentioned several times that he was observing us since many months. We are unable to figure out the real intention and are very scared by this incident.

I request you to kindly file FIR under section 354 and other applicable sections which deems fit.

I have recorded some video which might be helpful in this case.
