Sub: - Complain against damage to WBSEDCL's LT distribution network by an unidentified vehicle at Naresh More, near Krishna Yubak Sangha on 31.10.2025.

Sir,

This is to bring to your kind attention that an unidentified vehicle had collided with WBSEDCL's LT Electricity Distribution Network situated at Naresh More, near Krishna Yubak Sangha, PS- Bhaktinagar, Dist. - Jalpaiguri & damaged that pole that caused huge financial loss to WBSEDCL as well as inconvenience to the people of the surrounding area due to disruption in supply of Electricity. The incident was first reported to our LT Mobile Van on 31.10.2025 at around 09:10 hours through WBSEDCL's centralized docketing portal (Ref. Docket No.: 89255952, Complainant Name: Narayan Pal, Mobile No.: 9832918099). As reported by the local people, the incident took place in the wee hours of 31.10.2025 & the responsible vehicle quickly fled the spot, hence couldn't be traced. The LT Mobile Van of Subhaspally CCC, immediately after receiving the information, rushed to the spot & did the necessary to avoid any undesirable incident & restored power up to the extent possible.

One LT Pole PCC 8Mtr. long along with associated fittings & accessories have primarily been assessed to be damaged because of the incident, cost of which is provisionally/preliminarily assessed to the tune of Rs. 20,000.00 approx. However, the damaged pole will be replaced by tomorrow i.e. 01.11.2025 to avoid any kind of mishap.

Hence, your good office is requested to take cognizance of the matter & take necessary action as per u/s 139 of the Electricity Act, 2003 (read with amendments) & other relevant laws of the land for the damage caused to WBSEDCL's property.
