Respected Sir,

I, Nilam Mukhia, resident of Salbari, Near Sarswati Bengala High School hereby submit this complaint and request that an FIR be registered and necessary action taken regarding an incident of assault, threats that took place on 03/11/2025.

Details of the incident are as follows:

- On 03/11/2025, at approximately 7:45pm, a street dog attacked my two adopted dogs in front in apartment gate. There's not at all safety going out from the home as these dogs are so aggressive. And one of my dogs was badly injured. I have already discuss with him this is very dangerous to feed the street dogs in a residential area and these dogs are very aggressive and increasing day by day.

- To protect myself and my animals, I took a stick and intervened. At that time a man *Budra Pratap* who was with the street dog began recording me on his phone and came very close. When he forcibly touched my face while recording, I removed his phone from his hand in self defence. After the phone fell, the same man pushed me. His family members then gathered and began to harass and intimidate me. At around 8:20 on the same day they banged on my door and threatened verbally that "he'll see me tomorrow." Their behaviour caused me fear for my safety.

As a result of the attack and the ensuing assault/threats, I fear further harassment and harm.

I request the following actions be taken by the police:

1. Register an FIR for assault, criminal intimidation.
2. Provide protection to me and my family as required and take immediate steps to prevent further harassment as we are only two members in my family. I'm looking after my brother who's under going through dialysis since 7 years.
3. Advise me on the procedure to recover compensation for damage to property and medical expenses for my injured dog.
4. Inform me of the next steps and the FIR number so I may follow up.

Attached are supporting photographs of the injured dog and CC camera footage of family came for harassment medical treatment recorded.

Please treat this complaint as urgent. I am available for any further information or to come to the station for a formal statement.
