In producing herewith following three arrested accused persons, namely 1) Sujit Das (23 years) S/O Nilpada Das of Bashjhar more, near Ranjan More, ward no 40, PS Bhaktinagar, Dist Jalpaiguri. 2) Amit Verma (35 years) S/O Indra Kumar Verma of Kurukshetra, Jhansha Road, PS City, Dist Kurukshetra, Haryana. 3) Sambhu Tamang (24 years) S/O Jash Bdr Tamang of Demdema near Corronation valley, PS Bhaktinagar, Dist Jalpaiguri. 4)Subodh Tamang (25 years) S/O Lt Thaumbol Tamang of Takdah hum Busty, Cantonm ent, PS Rungli Rungliot, Dist Darjeeling, along with following seized articles viz:

1) One iron made wrench having length approx. 8 inches recovered from the exclusive and Conscious possession of Sambhu Tamang.

2) One iron made plier having length approx 6 inches recovered from the exclusive

and Conscious possession of Amit Verma.

3) One iron rod length approx. 15 inches recovered from the exclusive and Conscious

possession of Subodh Tamang.

4) One yellow colour iron made hammer having length approx. 10 inches recovered from the exclusive and Conscious possession of Sujit Das.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted and 10/11 others to the effect that on 04.11.2025 at 00:05 hrs received a specific source information that 14/15 miscreants have assembled at Eastern bypass amtola road, Opposite of Himalaya Kanya Abasan under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 167/25 dated 04.11.2025 and as per order I along with SI Srimanta Chatterjee, ASI Dhurba Misa, Khagen Barman C/374 Debraj Biswas, C/1434 Ananta Ram Bara all of Bhaktinagar PS, SPC, left for PEastern bypass amtola road, Opposite of Himalaya Kanya Abasan under Bhaktinagar PS to work out the information in hand.

At about 00.15 hrs we arrived at Eastern bypass amtola road, Opposite of Himalaya Kanya Abasan under Bhaktinagar PS as indicated by the source we noticed that 13/14 persons assembled at Eastern bypass amtola road, Opposite of Himalaya Kanya Abasan under Bhaktinagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04(four) of them with deadly weapons in their possession but 10/11 persons managed to fled away from the spot taking the advantage of darkness and open place.

On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 04.11.2025 in between 00.25hrs to 01.05hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a
specific case under proper section of law may kindly be started against the above noted
04 (four) arrested accused persons and others kindly arrange for its investigation.
