Sir/Madam,

I, Gopal Tiwari, a resident of Amrapali Residency, Ward No. 41, Zila Parishad Road, Siliguri, wish to lodge a formal complaint against Mr. Gagan Verma for repeated instances of public nuisance, misconduct, and intimidation.

Mr. Gagan Verma & Meera Verma of 100 Pearls Flat no K3 mobile no 9284053662, who regularly arrives in his vehicle bearing registration number PY05N8685, brings his dog to our locality and deliberately allows it to defecate near the boundary of our flat on a public road. This continuous act has created severe unhygienic conditions and inconvenience to residents, amounting to public nuisance under the relevant provisions of law.

On 02-11-2025, at around 6:26 PM, when I confronted him about this behavior, he responded aggressively, issued threats, and made false and baseless allegations against me. Later, at around 9:49 PM, he again came to my apartment (Amrapali Residency) and threatened and intimidated me, creating fear and disturbance in the locality. He and his wife have also been spreading false accusations of women harassment against me as they are in capacity of Lawyer, apparently to harass and defame me.

Furthermore, I would like to draw your attention to the serious **health and environmental hazards** caused by allowing dogs to defecate in public areas. Dog feces contain harmful bacteria, viruses, and parasites that can cause infections like *E. coli, Salmonella, Campylobacter*, and *Toxocariasis*. It also contributes to **water pollution**, unpleasant odor, and environmental degradation.

Such conduct violates municipal sanitation norms, and his threatening behavior constitutes offences under sections relating to criminal intimidation, public nuisance, and defamation.

Therefore, I kindly request you to:

- 1. Register this complaint as an FIR against Mr. Gagan Verma and his wife.
- 2. Take immediate legal action to prevent them from continuing such acts.
- 3. Ensure **safety and cleanliness** in the area by appropriate enforcement under relevant laws (including IPC sections pertaining to public nuisance, intimidation, and false allegations).
