With due respect, I ASI Sk Tinku producing herewith two (02) arrested accused persons namely (i) Abdul Kader (M/27 years) s/o Afjal Hussain of vill-Kalyanpur, PO +PS- Bagun, Dist. Goalpara, State- Assam (not verified) (ii) Jakir Hussain (M/42 years) s/o Zamaluddin of vill- Kacharipaty, PO Ambari, P.S Abhyapuri, Dist. Bongaingaon, State- Assam (not verified) along with following articles/cattle under seizure;

One red color Tata Motors Ltd. vehicle having display no. AS-01NC-2057 along with its key loaded with seventeen (17) number of Cows.

One forged vehicle number plate (iron sheet) having display no. AS 25FC 4369.

I beg to report that today on 03.11.2025 at 21.05 hours while performing mobile van duty vide Bhorer Alo GDE No.103, Dated.03.11.2025 and MCC No.- 337/2025, Dated - 03.11.2025, received a source information that one vehicle having display No. AS-01NC-2057 carrying cattle illegally is coming from Siliguri side towards Jalpaiguri via Balaram Road under Bhorer Alo PS. Accordingly, I shared the information with O/C PS and as per his direction, I along with C/625 Bhaben Das and NVF/492 Paresh Ch. Roy had been to Balaram road and waited for the vehicle to arrive to verify the veracity of the information. This refers to Bhorer Alo PS GDE No. 118, Dated. 03.11.2025.

At about 21.35 hours the above noted vehicle having display number AS 01 NC-2057 approached towards us at Balaram Road at Balaram under Bhorer Alo P.S. Accordingly our Police team stopped and detained the said vehicle having display No. AS-01NC-2057 along with the driver and one helper of the said vehicle. On interrogation the driver disclosed his name as Jakir Hussain (M/42 years) s/o Zamaluddin of vill- Kacharipaty, PO Ambari, P.S Abhyapuri, Dist. Bongaingaon, State- Assam (not verified) and the other person was identified as Abdul Kader (M/27 years) s/o Afjal Hussain of vill-Kalyanpur, PO +PS- Bagun, Dist. Goalpara, State- Assam (not verified).

On being asked, the driver of the vehicle disclosed that the vehicle is occupied with cattles which they had procured from Islampur area for transporting the same to Assam. After conducting search of the vehicle, found seventeen (17) number of cattles inside the vehicle kept in such a manner or position as to subject to unnecessary pain or suffering to the cattles. One forged number plate (iron sheet) having display number AS 25FC 4369 was also found below the driver seat.

Further, on demand of purchased bill, transportation permit and other veterinary certificates and other valid documents in respect of cattles and vehicles, both the detained persons failed to produce the same. The driver of the vehicle could not produce any valid documents in respect of forged number plate having display no AS-01NC-2057 and display number AS 25FC 4369.

Further, being interrogated, they admitted that they were carrying the cattle illegally being procured in fraudulent means and were loaded from Islampur side to dispose the same somewhere in Assam.
