Sub: FIR against truck driver having Registration No. PB-05-AQ-7837 and others for transporting coal dust illegally.

Sir,

In producing herewith one accused person named 1) Mangal Singh Guraiya (45 yrs) s/o Lt Bharat Singh of Gwalior, PS- Atri, Dist. Gwalior, Madhya Pradesh under arrest along with one Truck having Regt. No- PB-05-AQ-7837 loaded with Coal dust under seizure, I, ASI Blnay Subba of New Jalpaiguri PS, SPC do hereby lodge this written complaint to the effect that on 02.11.25 at 14.05 hrs, I along with force detailed for Naka checking duty at Gothmabari near Fulbari toll plaza. During Naka checking duty at about 19:30 hrs we noticed one truck having Registration No. PB-05-AQ-7837 was coming from Jalpaiguri side following NH 31. After noticing Police team, the driver of the Vehicle tried to flee away by high speed but somehow we could be able to detain the said truck at Gothmabari near Fulbari toll plaza. On interrogation the driver of the trucks disclosed his identity as noted above. We also found that the truck was loaded with coal dust. On demand the driver of said truck could not be able to produce any document like Transit Paper, Mining paper, Invoice, GST Bill etc, in respect of the loaded coal dust. On interrogation he furnished incoherent statements. He only confessed that the coal dust getting loaded from a place in Guwahati Assam was transported to Bardhaman.

Under the above facts and circumstances there is strong reason to believe that the above poted driver in connivance with others procured the said amount of coal dust fraudulently with knowledge to be stolen property to sell the same to our state for their wrongful gain. So, I seized the said truck along with available documents loaded with coal dust under proper seizure list in between 20.30 hrs and 20.50 hrs from the possession of the said driver in presence of witnesses. Then I arrested him after issuing them proper memo of arrest, serving the paper of ground of arrest at 20.55 hrs. He stated that since long he along with their associates have been doing this business of coal following this manner for their illegal gain.

Hence, it is requested to register a specific case against 1) Mangal Singh (45 yrs) s/o Lt Bharat Singh of Gwalior, PS- Atri, Dist. Gwalior, Madhya Pradesh and others under proper section of law and arrange for its investigation.
