I ASI Nilam Swarnakar of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 06/07 persons to the effect that on the night 06.11.25 at 00.10 hrs. received a secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Kashmir Colony Ucha math under NJP PS with a view to commit dacoit. Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 256 dated. 06.11.25. As per your kind direction at 00.15 hrs myself along with C/453 Uttam Dey, C/1462 Sajan Tamang, VP-13 Jamirul Islam, VP-08 Laxman Roy left from PS vide NJP PS GDE No. 257 dated. 06.11.25 for Kashmir Colony Ucha math to verify the veracity of the information and to work upon it. We reached hear the spot as confirmed by the source at about 00.20 hrs. and stopped our vehicle at a considerable distance from that place and we started walking towards the mentioned place. When we reached at Kashmir Colony Ucha math and found a group of 09/10 persons assembled and gossiping in a dark place as stated by the source. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from the spot. Somehow, after a hot chase we could able to apprehend the above noted Three (03) persons and the others 06/07 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoit after making full preparation in the nearby place of Kashmir Colony Ucha math under NJP PS. Thereafter all the apprehended persons were searched and I found and recovered the above noted articles from their possession and seized the same under proper seizure list duly signed by them in present of independent witness and the process of search and seizure has been recorded in audio-video means as per the provision of law. The seizure was made on 06.11.2025 in between 00.25 hrs to 00.55 hrs. Accordingly I arrested the above noted accused persons u/s 35 BNSS under proper memo of arrest and ground of arrest is duly communicated with them.

So I pray before yourself that a specific case may kindly be started against the accused persons named 1. Shambhu Das (35 yrs.) s/o- Lt Mangal Das of Sreenagar Colony, Shantipara, PS- NJP, Dist. – Jalpaiguri, 2. Md. Sahid Alam (24 yrs.), S/o – Md.
