Subject: Written Complaint Against My Husband for Continuous Physical and Mental Torture, Cruelty, and Attempt to Murder.

Respected Sir/Madam,

I, Smt. Anjana, wife of Sri Subodh Kumar, daughter-in-law of Late Laxmi Prasad, residing at Flat No.- 2A, Building No. 3, Sangam Residential Complex, Near Check Post, P.O- Salugara, P.S- Bhaktinagar, District- Jalpaiguri, Pin-734008, wish to lodge this written complaint against my husband, Sri Subodh Kumar, who is an Engineer in N.H.P.C. and residing at the same address, for continuous physical and mental torture, cruelty, domestic violence, and attempt to murder.

Our marriage was solemnized on 15.02.2004 at Bihar according to Hindu rites and customs. It was an arranged marriage arranged by my parents. After about one year of marriage, my husband started mentally torturing me for small matters and also for visiting my sister's house in Bihar for her pregnancy, which I had visited even before marriage. In 2005, our first girl child was born and my husband became furious as he wanted a boy child. Thereafter, he started mentally harassing me through phone and subjected me to cruel treatment.

In the year 2008 I along with my husband and daughter went to bihar for attending a family function then at the function he started quarrel of the past incident when I visited my sister's house and started creating a bad scene at the function and then later apologized to my parents and then we came to Siliguri.

After three miscarriages, in 2014, another girl child was born. My husband again started assaulting me and torturing me mentally and physically, saying that he wanted a boy child. He threatened to remarry and divorce me. In 2015, a boy child was born, but even then, he continued his abusive behaviour and repeatedly expressed his desire to marry another woman.


In 2018, he brutally assaulted me with fists and kicks and strangulated me to such an extent that I fell unconscious. My children saved me and then I called my parents over telephone, who came immediately. My husband then

Anjema 7/11/25 apologized by touching their feet and promised not to repeat such behaviour, but he again continued to torture me for small matters. He became extremely controlling and installed three CCTV cameras inside our flat so that I could not talk to any neighbour. I was required to take daily instructions from him for cooking and to send him photographs of food. I was not allowed to go outside without permission, and if I did, he used to assault me. My children were also not allowed to go outside and play. He used to check the CCTV footage every day.

My husband took all my jewellery and kept it under his custody and did not allow me to wear them. He always used abusive and vulgar language against me in front of our children, and whenever I protested, he assaulted me. He also assaulted the children if they came to my rescue. If for any reason I failed to receive his phone call, he used to beat me. When I had to go outside for any emergency, he forced me to wear a pen camera so that he could later check the recordings.

The flat where we reside was in our joint names. In 2022/2023, my husband forcibly took a gift transfer of my share in the flat by threatening that he would stop paying for our children's education and basic household expenses. Under mental pressure, I was compelled to gift my share of the flat to him. In 2023, he again demanded that I call my parents and tell them that he wanted to remarry and that I had no objection. He also asked me to transfer a plot in Bihar, which was in my name, to him. When I refused, he assaulted me brutally and forced me to transfer that property as well.

Despite continuous inhuman torture and assaults, I tolerated everything for the sake of my children's future. However, his violence and cruelty have only increased. On 05.11.2025, my son was suffering from a tooth cavity, and my husband took him to the doctor. After returning home, he started abusing me in filthy language without any provocation and assaulted me. Again, on 06.11.2025 at around 11:00 A.M., he used vulgar words against me in front of my children, and when I protested, he slapped me, punched me in the face, kicked me on my stomach, and beat me mercilessly. When my children tried to save me, he threatened them. He then picked up a steel curtain rod and ordered me to apologize by touching his feet. When I bent down to do so, he struck me forcefully with the steel rod on my back, head, and shoulder, and then strangulated me with his hands. I fell unconscious. My elder daughter secretly recorded the incident on her mobile phone before coming to rescue me and later my husband deleted the storage of the CCTV camera installed in our flat.



I am presently living under constant fear for my life and that of my children. My husband's violent behaviour, mental torture, and repeated threats have made it impossible for me to live peacefully. I therefore request you to kindly register my complaint as an FIR against my husband, Sri Subodh Kumar.

Kindly take necessary and appropriate action at the earliest.
