
Respected Sir,

With due respect I, Manju Sahani, Wife of Chandesar Sahani, resident Rajendar Prasad Road, Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal begs to state that at about 09:00pm on 06.11.2025 the following persons namely (1) Santosh Sahani, S/O Late Nanki Sahani, (2) Vikash Choudhury, S/O Not Known, (3) Chandan Sahani, S/O Late Babaji Sahani, (4) Ajay Sahani, S/O Late Babaji Sahani, (5) Nishu Sahani, D/O Late Nanki Sahani, and (6) Neha Sahani, D/O Late Nanki Sahani, all are residents of Sahani Busty, Prakash Nagar, Ward No. 43 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal suddenly forcefully entered my house at the aforesaid resident and started assaulting me and Sister-In-Law Manisha Sahani with wooden battams and iron rods. The aforesaid person tore the clothes that I and my sister-in-law had worn and also assaulted the infant baby of my sister-in-law with an intention to take our lives. Thereafter, we started shouting and crying the aforesaid person left our resident but forcefully abducted my bother Sikdar Sahani and took him to the Mahanadi River and started assaulting him with a serious intention to take his life. Somehow my brother managed to escape from their grasp and returned home where we had to go for medical treatment. They left my house threatening us with dire consequences with a threat to my and my family's well being and life.

So I therefore request you to kindly look into the matter and do the needful and start a specific case against the aforesaid person under the provisions of law.

I shall be highl obliged for this act of kindness.
