I, the undersigned of the Neotia Getwel Multispecialty Hospital (A unit of Ambuja Neotia Healthcare Venture Limited) having office at Uttarayan, behind City Centre, Siliguri- 734010, would like to inform you the following facts and circumstances: -

One unscrupulous person entered our hospital namely Neotia Get-wel Multyspecialty Hospitalat situated at Uttarayan behind City Centre ,around 6.15pm yesterday i.e. on 06/11/2025. He proceeded to the OPD waiting area , sat on a chair , and placed a black bag , which he kept with him throughout the night . Today i. e. on 07/11/2025 approximately 7 am in the morning the said unscrupulous person moved from the OPD assessment area to the EEG room and stole a laptop. He then entered OPD room no. 14 and Stole two tablets. After committing the theft he left the hospital premises at around 7.12 am i.e. on 07/11/2025 and was later seen moving away from the city centre. It is pertinent

to mention here that before stealing the items at around 7.01 am he visited the pharmacy and purchased two medicines. The medicine bill number is

NGCHS/25/66880, and the payment was made via UPI 9315964981@airtel. The Retrieval Reference Number (RRN) for the transaction is 531107261183 (Vijaya

I, therefore, request you please take note of the aforesaid facts and circumstances and take necessary action against the said persons as mentioned above as per appropriate provision of law.

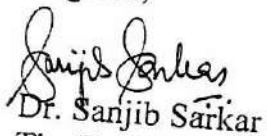
