Sir,

In producing herewith 05 (five) accused persons namely (i) Nikhil Paswan (22 yrs) S/O Bharat Paswan of Rajendra Nagar, Cooliepara, Ward No. 01, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Sanjok Thapa (25 yrs) S/O Gajbir Thapa of Rong PS-Jorthing, Dist.- Namchi, South Sikkim (iii) Ganesh Ghatri (26 yrs) S/O Ram Bahadur Ghatri of Tadung, PS-Tadung, Dist.- East Sikkim (iv) Sahil Rai (23 yrs) S/O Bimal Rai of DPH, PS-Sadar, Gangtok, East Sikkim, (v) Tahering Dorjee Bhutia (25 yrs) S/O Tahering Bhutia of Chitbo Busty, PS-Kalimpong, Dist.-Kalimpong under arrest along with the following seizure articles viz:- (i) One iron made weapon locally called an "BHUJALI" measuring approx 20 inches in length including its 06 inches wooden butt. (ii) One iron made weapon locally called "HASUA" measuring approx 22 inches in length including its 07 inches wooden butt. (iii) One iron made weapon locally called "HASUA" measuring approx 25 inches in length including its 07 inches wooden butt. (iv) One iron made weapon called as "SABOL" measuring 22 inches in length. (v) One iron made weapon called as "SABOL" measuring 23 inches in length. (vi) One iron made weapon called as "HAXO BLADE" measuring 19 inches in length including its 05 inches wooden butt (vii) one iron Hammer measuring 09.5 inches in length. (viii) One red colour iron made instruments called as "PLUS" (ix) One black and blue colour torch light and (x) One multi nylon bag. I, SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted five (05) arrested accused persons and others 06/07 unknown miscreants who involve in this crime, to the effect that on 08.11.25 at 23.40 hrs I received a specific source information that about 11/12 miscreants equipped with deadly weapons assembled at BRI Colony, near Hindi Primary School, under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at BRI Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 484 dated 08.11.2025 and informed the matter to you. As per your kind order and direction, I along with ASI Biplab Kr Das, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for BRI Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar PS GDE No 485 dated 08.11.25. I also informed night RT van officer ASI Amar Raj Subba and requested him to come to BRI Colony near Hindi Primary School to accompany us as well informed to one camera man namely Somnath Chatterjee S/O Sushil Chatterjee of Santinagar, Boubazar, PS Bhaktinagar, Dist Jalpaiguri over mobile phone and requested him to come to BRI Colony under Pradhan Nagar PS, Dist.- Darjeeling with his video camera for the purpose of videography, if required. At around 00.05 hrs on 09.11.25 we arrived at BRI Colony near Hindi Primary School under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer ASI Amar Raj Subba and above mentioned cameraman Somnath Chatterjee arrived at the spot to accompany us. I shared the information with my raid team and briefed them properly. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Avijit Thakur (21 yrs) S/O Brajmohan Thakur of Gate Bazar, Ward No. 01, PS Pradhan Nagar, Dist.- Darjeeling and (ii) Mahesh Sha S/O Lt. Chandrika Sha of Gate Bazar, Ward No 01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 11/12 persons were assembled in a class room of Dr B.R. Ambedkar Colony Hindi Primary School, and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above named five (05) accused persons while 06/07 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such dead hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at BRI Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 00:50 hrs. to 01:20 hrs on 09.11.25 at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest and also provided them written information regarding ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with 06/07 of their associates who fled away, gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at BRI Colony.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted five (05) arrested accused persons namely (i) Nilhil Paswan (22 yrs) S/O Bharat Paswan of Rajendra Nagar, Coollepara, Ward No.-01, PS-Pradhan Nagar, Dist.- Darjeeling (ii) Sanjok Thapa (25 yrs) S/O Gajbir Thapa of Rong PS-Jorthang, Dist.-Namchi, South Sikkim (iii) Ganesh Ghatraj (26 yrs) S/O Ram Bahadur Ghatraj of Tadung, PS-Tadung, Dist.- East Sikkim (iv) Sahil Rai (23 yrs) S/O Bimal Rai of DPH, PS-Sadar, Gangtok, East Sikkim, (v) Tshering Dorjee Bhutia (25 yrs) S/O Tshering Bhutia of Chibo Busty, PS-Kalimpong, Dist.-Kalimpong and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.
