I, Smt. Sangita Prasad, w/o

P.O. & P.S. Pradhan Nagar, Dist. Darjeeling do hereby
beg to inform that one Gita Thakur, w/o. of
nd known of Jaldhama, Siliguri started working
in my flat as maid servant since 24/09/25.
That time my sister's daughter namely Mamta
Chauhan has come to stay in my house for
Diwali and Chheth Puja celebration. On the
occasion of Diwali my said cousin daughter
Mamta Chauhan took out her gold earrings,
gold nose ring and bangle and kept it on
the T.V. table and went with me to city
centre. That time said maid servant Gita
Thakur was at my house. She used to stay
at my house. After returning from city
centre late night we forgot to keep the
jewellery and got engaged in chheth puja
consequently from the next morning.
Taking this advantage said Gita Thakur
stole every the jewellery from the T.V.
table.

Sir, The following day she left the work and went away, we requested her to do the work till chhath puja but she did not agree. On the day of chhath puja evening when I and Manta started searching for the jewellery as to wear but could not find it. We searched everywhere but could not find. Then we recollected that the jewellery were on the T.V. table and Gita the maid servant was at home that time and she have theft away the jewellery. I tried to make contact with her but no response. But two days back I received a phone call from a mobile no 7478141989 who demanded to give the salary of Gita Thakur. I asked him to send Gita to take the salary.

Sir today when Gita Thakur with her three associates came to take money to our apartment. The Guard called me at about 11:30 A.M. That time my husband Tushar Daz was out of home for some work. When he came at the main gate of the apartment that time said Gita Thakur and her men stopped my husband and started abusing him, since then he came to the flat and informed me about the incident. I then came down and seeing Gita Thakur I asked her about the jewellery which she has taken. She flatly denied of taking the jewellery. Then the three men with her started abusing me in slang language. When I protested then one of the men started assaulting me with fist and blow and caught hold of my

clothes and on my screen my cousin Mante came to save me, then other two men also joined him and all started assaulting me and Mante and they all touched our private parts with intention to disrobe us. Gite Thakur also joined them and pulled our hairs. I and Mante both sustained severe injuries. Peoples assembled there saved us.

Then said Gite Thakur and her men left the place threatening me and my family men born of dire consequences.

Sir, said Gite Thakur with intention to cause harm to us and in a preplanned way her came to our flat and they are dangerous persons. I and Mante charan went to Shigum Dist. Hospital for treatment. We are still feeling not well. We are living in fear of being attacked by them again.

I therefore request you Sir to enquire into the matter and take necessary legal action against Gite Thakur and her three men or per law and protect us from their hands.
