1. That on 09.11.2025 at about 12:00 P.M. I was going to laundry and at the said moment one piece of brick suddenly hit my left foot and suddenly one person namely **RAHUL** started threatening me and claiming me that he got hit by the same brick.
2. That at the said moment I ignored him and I went to laundry and I was returning from laundry to my home on the same way then suddenly he started abusing and hitting me in front of my house.
3. After that he grabbed my collar and torn my shirt, kicked me on my chest, then I fell down on the road and a serious cut happened on my left hand and due to the above circumstances I was trying to save myself but could not manage to do that because he was a young person and I am an old person.
