I, Panya Das, Wife Of Amit Das, I am writing to report a theft that occurred at my residence, Shyama Smriti House, Nearby Italian Ground, Netaji Pally, Ghogomali, Thana-Ashighar, Siliguri, Pin-734006.

The incident took place during the early morning hours of today, November 8, 2025, sometime between 12:30 AM and 5:15 AM. While my family and I were sleeping, an unknown person or persons unlocked a window latch from the outside, gained access to the room, and stole two of my mobile phones.
