Sir,

I, the undersigned, Under compelling circumstances do hereby lodging a written complaint against Suman Roy, s/o Jagganth Roy of Subash Pally, Lichu Bagan, Ward no.18, PS – Siliguri, Dist- Darjeeling, approximately 200 members of Siliguri Town Club, Bagrakot Bus Stand, Siliguri and some transgender persons, to the effect that I, Inspector Mumtaz Begum, IC, Siliguri Women PS, SPC, was performing Durga Puja immersion duty along with the Winner (East Zone) team, Siliguri Police Commissionerate, as per deployment at Airview More, Siliguri. The team members consisted of LASI Nupur Mitra, LC/519 Dharitri Roy, LC/545 Mampi Roy, LC/1224 Mousumi Roy, LC/1229 Rimpa Roy, LC/1236 Sarothi Das, LC/1247 Lakpa Doma Sherpa, LC/1262 Youna Pradhan, LC/1264 Radha Rai, LC/1292 Cheden Bhutia, LC/1299 Rosy Lepcha, LC/1326 Subarna Singha, and LC/1345 Pritika Khawas, vide MCC No. 286 dated 03.10.2025.

On 04.10.2025, at around 00:05 hrs, during the immersion procession of Goddess Durga of Siliguri Town Club, while our team was positioned along the road at Air View More, Siliguri certain members of the said club began verbally abusing us by shouting, “West Bengal Police Madarchod.” When questioned regarding such derogatory remarks, amongst the miscreants one person namely Suman Roy, s/o Jagganth Roy of Subash Pally, LiChu Bagan, Ward no.18, PS –Siliguri, Dist- Darjeeling, further escalated the matter by hurling derogatory indecent words which resulted into tarnishing the modesty of not only the persons in uniform but as also to their modesty as a women and instigating the accompanying crowd, which was approximately 200 in number, including some transgender persons.

As a result of the constant instigation, the mob soon turned violent, uncontrollable and unlawful. Despite repeated requests made to them to calm down, they continued their aggressive behavior. Being a responsible Police team of Siliguri Police Commissionerate, it was contemplated from our side that despite of facing the derogations, our team remained to be committed to keep up the peace and tranquility by performing our duties.

However, the said Suman Roy along with the other miscreants was determined to deter us from performing our duties as public servants by using criminal force. When I the undersigned approached the said Suman Roy and other miscreants to stop them from doing such type of unruly behavior, to my shock and surprise the said Suman Roy shouted to instigate others to cause stampede with specific a cry to kill me. Being prevented from doing such act, within the miscreants the said Suman Roy cried out to the uncontrollable mob to accumulate any weapon they can get their hands on. Resulting from that specific instigation the miscreants charged up on me and the other Winner (East Zone) team lady police officials with iron roads and bamboo sticks, resulting from that the miscreants charged upon me with direct hurling and intention of killing me, during that course I was pushed down to the street, several times I was kicked on my head and chest by the said Suman Roy and other miscreants for several times with no other intention but to cause my death. While the above named Winner (East Zone) team members tried to save me from that death pit, the miscreants torn

apart the uniforms of some winner team members resulting into the outrage of modesty of those police personnel as well as leaving them severely mentally and physically injured. One transgender individual deliberately lifted sari and exposed private parts with the intention of insulting and maligning the image of the police. The transgender persons also used obscene language and assaulted Winner (East Zone) team members.

As we remained surrounded and under continuous attack, to prevent possible loss of police lives, I immediately informed my superior officers. Subsequently, reinforcement was deployed, and we were rescued. The police team used minimal force to disperse the unlawful mob, after which they fled. One person, namely Suman Roy, was apprehended by the police team. I, along with the Winner (East Zone) team members, received medical treatment at Siliguri District Hospital.

The said Puja Committee and Club are not registered entities and have no legal permission from the appropriate authorities to perform the puja or conduct the procession.

Therefore, I request you to register an FIR against Suman Roy and other approximately 200 members of Siliguri Town Club, Bagrakot Bus Stand, Siliguri and some transgender persons for the offences committed as stated above and take necessary legal action against them.
