Respected Sir,

I, Const/1554 Mrinal Newar presently posted Crime Section of SPC lodging this written complainant against two unknown male persons to the effect that today myself along with ASI 104 Sanjay Roy, CV 1043 Pappu Roy and THG Rohit Kumar Prasad were deployed at Traffic Point of Fly Over near Siliguri PS to perform law and order as well as traffic duty in connection with Durga Puja Festival-2025 under Siliguri PS jurisdiction vide MCC No-3146/2025 Dated-02.10.2025 and till 21:50 hrs the situation of the said area was peaceful so far.

At around 21:55hrs while processions of 'Durga Idol' were passing through our deputed area, we were busy to maintain traffic and Law & Order management then two unknown persons by scooter bearing Reg No. WB 74 BS 7288 who introduced themselves as father and son appeared before us and stated us that why the Puja Committee making chaos and shouting, I then tried to make them understand that the devotees are going to immerse Durga idol at Mahananda River and they are shouting in the name of MAA DURGA but in vain. They continuously pressuring me to stop the processions and started uttering ill words towards the members of the immersion processions. As the members of the carrying on procession peacefully by maintaining all sort of guideline and other public in general neither reported nor objection against the issue, I therefore found nothing to stop the processions. Then I requested them to stop using ill words to the devotees they pay no heed to my words and became aggravated and they tried to stop the processions. Seeing the situation going out of control I requested them to leave, after hearing my words they became more aggravated and started abusing me verbally and when I raised objection on their doings they restrained me and pushed me and restrained me to perform my government duty. Seeing their act other officers and force came to rescue me then both the persons with their bike escaped from the spot.
