Respected sir,

With due respect I Panchomi Barman w/o Rahul Biswas d/o Swapan Barman , aged about 21 years ,presently residing at Baribhasha, Madani Bazar, Sahudangi Hut, P.S. Njp, Dist jalpaiguri would like to draw your kind attention on the following effect that approximately four months ago I got married with one Rahul Biswas s/o Bimal Biswas under Hindu rites and customs in presence of both family members and at the time of marriage as per their demand My mother paid them Rs.50,000/- ( Fifty thousand) , few gold and silver ornaments and other home appliances. After marriage I went to my matrimonial house to live my conjugal life. But soon after my marriage the above mentioned persons started torture me by physically and mentally and also put pressure upon me to bring more money and when I refused to pay they regularly beat me and not only that most of the day they did not provide food to me and most of the time they keep me in a lock home. I would also like to mention here that three times the Panchayat Pradhan with the help of local people try resolved this situation but they again and again repeatedly done the same things. On 11.10.2025 at about 2.00 p.m. my husband and my in laws asked me to bring Rs. 2,00,000/- ( two lakhs) rupees from my parental house and when I refused them they with out any reason started using filthy languages and also beat me here and there and also kicked me on my chest not only that try to broke my hand leg and hold my neck to kill me and also state that if I do not bring the money they will burn me with Kerosene oil , finding no other alternative when I started shouting they leave me and somehow I fled away from there and took shelter to my neighbor house and they called my parents

but when my parents came to settled the matter they clearly stated that if my father did not give them money , they did not keep me in their house and on the same day they drove me from their house. Finding no other alternative I took shelter to my parents house. In the month of August I took to Siliguri District Hospital as because they punch on my ear as a result I sustain grievous injury on my ear and the medical prescription also present but at that time I did not logged any complaint by thinking that one day everything will be alright.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities.
