Police Commissionerate, hereby lodge a written complaint stating that today, On 08.11.2025, at approximately 17:35 hrs, while I was engaged in social media monitoring duty at Cyber Crime Police Station, Siliguri, I came across a Facebook user named "Puja Mahato" (profile link: https://www.facebook.com/puja.mahato.245929) who had posted communal and provocative video comments targeting a video clip depicting members of the Muslim community gathering and performing religious rituals with a subject " ये कौनसी भक्ति है भाई" on 08.11.2025 at 3.50 PM. The link of the video comments is <a href="https://www.facebook.com/reel/2039785683476540">https://www.facebook.com/reel/2039785683476540</a> .

The circulation of such inflammatory content on social media amounts to abetment of communal violence and has the potential to incite unrest among communities within the jurisdiction of Siliguri and its surrounding areas.

The user. Puja Mahato, daughter of Late Jamin Mahato, residing at Tulsi Nagar. Kholaibaktari, PS Matigara, has previously uploaded similar provocative content. A case was registered against her under Cyber Crime PS Case No. 106/25 dated 25.09.2025, under Sections 196(1a)/(1b), 353(2), and 299 of the Bharatiya Nyaya Sanhita (BNS). She is currently out on anticipatory bail granted by the Vacation Judge, Siliguri, with a directive not to enter the residential jurisdiction of Tulsi Nagar. Her continued posting of communal and provocative video comments may expose her to retaliatory actions, which could pose serious communal tension between two communal groups (Hindu & Muslim) in her locality

Under the above circumstances, I pray that you kindly register an FIR against the Facebook user Puja Mahato D/O Jamin Mahato, residing at Tulsi Nagar, Kholaibaktari, PS Matigara under proper section of law.
