With due respect and humble submission I SI Jayunta Wart Holing Commission P.S. beg to submit that today on 12/11/2025 I was deputed to perform Mobile Patrol duty along with force from 07:55 hrs vide Matigara P.S. C.C. No. 2336/25, Dated 12/11/2025 and O.D. Entry No. 577, Dated 12/11/2025.

During my said duty I received information that some people were gathered on Asian Highway - 2, near Balason Traffic Guard Out Post, P.S. - Matigara, Dist.- Darjeeling and trying to block the Asian Highway. As such I along with my force rushed to Balason Traffic Out Post at about 13:40 hrs and found that a group of 30/35 unknown persons, both male and female already blocked the Asisan Highway - 2, opposite Balason Traffic Out Post under PS - Matigara in demand of their various issues. As such vehicular and pedestrian movement of both side were totally blocked. Huge vehicles were trapped in traffic jam. I requested them to leave from Asian Highway but in vain. I informed the matter to I/C Matigara P.S. regarding the matter and after sometime re-enforcement of Police reached at the spot. We all requested them to clear the Asian Highway - 2. However, at about 13:55 hrs they left from Asian Highway - 2.

This is a deliberate attempt to disrupt the smooth movement vehicular traffic as well as pedestrian movement, resulting huge vehicle including emergency service like vehicles carrying Ambulances, Army vehicles, Airport bound vehicles, milk/water/medicines etc. of both sides were effected.

Under this circumstances, I pray before your kind honour that a specific case may kindly registered against 30/35 unknown people both male and female for their deliberate attempt to disrupt the smooth movement vehicular traffic including emergency service.
