Sir.

With due respect and humble submission I ASI Bikash Barman of Matigara P.S do hereby lodge this written complaint to the effect that today (12.11.25) in course of my mobile van duty vide Matigara P.S. C.C. No. 2344/25 and GDE No. 595 Dated 12.11.25, received source information that one vehicle (Dumper) is coming from Balason River side towards Khaprail More side under Matigara PS loaded with river bed material (Bolder) which were procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed towards Khaprail More. On the way near Indian Oil Petrol Pump at Nemai area under P.S.- Matigara I found one Dumper bearing Regn. No WB-73 H -0274 loaded with river bed materials (Bolder) was coming towards Khaprail More, we managed to detain said vehicle and asked the driver to produce document in respect said loaded river bed materials (.) On demand he handed over one Mobile phone which showing one road e-challan, vide e-challan No.2843857/T/25-26/121120250239/PS Dt. 12.11.25. I checked the said voucher after scanning the QR code I found that the said voucher was already expired which was issued on 12.03.25 at 05.02 PM validity till 02.02 AM on 13/03/25 only. In the mean time the driver of the said vehicle somehow flew away from the spot. Finding no other alternatives, I seized the said vehicle loaded with river bed materials and mobile phone from the spot as abandoned condition in presence of local witnesses, under proper seizure list.

It is crystal clear that the driver/owner of the vehicle Tata Dumper bearing Regn. No. WB-73 H -0274 procured the loaded river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain procuring forged documents from elsewhere. The seizure was made in between 20.50 hrs to 21.10 hrs under videography...

I therefore, pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Tata Dumper bearing Regn. No. WB-73 H -0274 and arrange for its investigation.
