Respected Sir/Madam,

I, SMT. CHHANDA SAHA, wife of Kajal Saha, resident of Purbanchal, Ward No. 2, Pradhan Nagar, P.O. - Champasari, P.S.- Pradhan Nagar, District - Darjeeling, West Bengal, would like to inform you the following facts:-

That I am a member of the women wing of a registered society under the name and style of "Purbanchal Development Committee".

It is pertinent to mention here that almost all the household persons of Purbanchal area are the members of the said society which was established with a view to look after the development and needs of the hour of all the residents of the area.

Every year we the lady members of the said society organize the event of Durga Puja near Ravi Ratna Nepali Girls School, the male members of the society used to look after and manage the chanda collection and funds, one Debraj Nandi, son of Debasish Nandi, resident of Purbanchal, Pradhan Nagar, being the Secretary is responsible for the monetary dealings of the organization as well as the Puja Committee.

On 07.10.2025, a meeting was held discussing the accounts of Durga Puja, 2025 at the above-mentioned School, after the meeting the accounts showed that the total expenses of Durga Puja, 2025 was Rs.3,00,8870/- (Rupees Three Lacs Eight Thousand Eight Hundred Seventy)only, but the collection amount and the expenses that has been dealt with is Rs. 2,00,38,190/- (Two Lacs Thirty Eight Thousand One Hundred and Ninety) only so it was unanimously accepted by the members that we had a deficit of funds amounting to Rs. 63,210/- (Rupees Sixty Three Thousand Two Hundred Ten) only and it was also decided that our said Secretary would withdraw such amount from the Bank account of the organization.

As per the resolution our Secretary has withdrawn an amount of Rs. 63,210/- (Rupees Sixty Three Thousand Two Hundred Ten) only on 29.10.2025 and he was supposed to make payment of all the dues.

Unfortunately in the recent past it came to our knowledge that the above-mentioned due amount of the Durga Puja were not duly paid instead said Debraj Nandi instead of paying the said due amount has misappropriated the fund in his personal use.

Yesterday a meeting was again held to discuss the above noted issue but our Secretary along with his associates have intentionally avoided attending the said meeting.

Today morning at around 10:00 a.m. my husband received a call and came to know that Secretary (1)Debraj Nandi alongwith (2) Debasish Nandi, son of Not Known, (3)Jayanto Nandi, son of Not Known, and (4)Debkiran Nandi, son of Debashish Nandi, all are residents of Purbanchal area had gone to the house of our President namely Sujit Kumar Dey, (President of Puja Committee), resident of Purbanchal Pradhan Nagar, attacked him and were assaulting him with fists and blows, knowing the same I along with my husband rushed to the house of President, while we weretrying to rescue our President and defend him, all the above noted person started assaulting my husband with fist and blows, with iron rod, lathi etc., while I was trying to save my husband all the above noted persons have also assaulted me with the intent to outrage my modesty, I was being molested by them, meanwhile other female members came to the spot and rescued us, on the process my husband suffered injury on his right leg and left hand, he was immediately taken to the Siliguri Hospital.

It is pertinent to mention herein that our Secretary till date has not returned the above mentioned amount which he has misappropriated.

At the time of the scuffle one of those persons have snatched away a gold chain which I was wearing.

In view of the above circumstances I request you to kindly investigate the matter and take appropriate action against the above-named culprits and I also request you to assist me in recovering our misappropriated funds at the earliest.
