**Subject: WRITTEN COMPLAINT**

against Mr. Ajay Kumar, Constable, Border Security Force (BSF), 57 Battalion, Raiganj, Dist. North Dinajpur, West Bengal, for deceiving and contracting marriage by concealment of existing marriage, Offences punishable under Sections 82, 83, and 318 of the Bharatiya Nyaya Sanhita, 2023.

Respected Sir/Madam,

I, SMT. RENUKA SINGH, Daughter of Late Ratan Kumar Singh, presently residing at Ambar Dhura, Shalbari, Post Office- Champasari, Police Station- Pradhan Nagar (Siliguri), District- Darjeeling, in the State of West Bengal, respectfully submit this complaint for your kind consideration and necessary legal action as follows:

1. That Mr. Ajay Kumar, serving as a Constable in the Border Security Force (BSF), at 57 Battalion, Raiganj, being I.D. Card No. 701275 and Personal No. 114032526 is a permanent resident of Sai Khurd Partly, Arnja, R.S. Pura, PIN- 181131, in the State of Jammu. (Mob. 9682541812 & 7051966917)
2. That I am a widow had been residing with my 15 years old daughter, Roshni Chetry at the above address, Mr. Ajay Kumar, a Constable in the Border Security Force (57 Battalion, Raiganj), through Facebook in May 2024 came into contact with me. Ajay Kumar introduced himself as an unmarried person, and over time, a close relationship developed between us.
3. In July 2024, the said Ajay Kumar visited my rented residence at Bhanu Nagar, Siliguri, and falsely represented himself as unmarried, thereby deceiving me and gaining my trust and affection. Subsequently, he proposed marriage to me. Believing his false statement and representation, I consented to marry him.
4. The marriage was solemnized on 03/05/2025 at "Mata Vaisno Devi Mandir" situated at Katra, Post Office- Katra, PIN- 182301, Udhampur, District- Reasi, in the State of Jammu, according to Hindu marriage customs and rituals. After marriage, we both started living together as husband and wife at the said rented

premises and later shifted to Ambar Dhura, Shalbari (P.S. Pradhan Nagar), where we maintained our conjugal relations with each other. During this period, he provided me with household expenses of about ₹30,000/- per month.

5. On 06/11/2025, I came to know that Ajay Kumar had concealed the fact of his existing marriage and that his first marriage was still subsisting, thereby deceiving and defrauding me. That his acts caused me severe mental trauma, emotional distress, social embarrassment, and loss of reputation.

Thus he committed offences punishable under Sections 82, 83, and 318 of the Bharatiya Nyaya Sanhita, 2023.

I therefore request you to register a case under Sections 82, 83, and 318 of the Bharatiya Nyaya Sanhita, 2023, investigate the matter thoroughly, and take appropriate legal action against the accused person according to law.

I am ready to produce all evidence to support my case, including marriage photographs, communications.

I therefore pray for justice and immediate registration of my complaint as an FIR.
