Sir,

In producing herewith 01 (one) accused person namely Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :-

- (i) One red colour packet wrapped with transparent cello tape containing 6.190 Kgs of Ganja - Marked as Exhibit-'A'.
- (ii) One red colour packet wrapped with transparent cello tape containing 6.264 Kgs of Ganja - Marked as Exhibit-'B'.
- (iii) One red colour packet wrapped with transparent cello tape containing 6.181 Kgs of Ganja - Marked as Exhibit-'C'.
- (iv) One red colour packet wrapped with transparent cello tape containing 6.818 Kgs of Ganja - Marked as Exhibit-'D'.
- (v) One red colour packet wrapped with transparent cello tape containing 6.790 Kgs of Ganja - Marked as Exhibit-'E'.
- (vi) One yellow colour plastic bag printed as NRSS GOLD TEA filled with Chayote (Squash) approx Weight 25 kgs - Marked as Exhibit 'F', in which Exhibits 'A' 'B' 'C' & 'D' was recovered.
- (vii) One yellow colour plastic bag printed as NRSS GOLD TEA filled with Chayote (Squash) approx Weight 35 kgs - Marked as Exhibit 'G', in which Exhibits 'E' was recovered.

I, SI Rajiv Subba S/O Basant Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above arrested accused person namely Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 12.11.25 at 22.20 hrs I received a reliable specific secret source input that one person would be come to Siliguri Junction with two numbers of vegetable loaded bags containing huge quantities of Ganja inside the vegetable bags. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 715 dated 12.11.25 and I informed you in writing. Subsequently, being directed by you at about 22.30 hrs myself along with SI Goutam Mallik, SI Bandhan Roy, ASI Biplab Kr Das, ASI Prabal Sarkar and others force of Pradhan Nagar PS, SPC left for Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 716 dated 12.11.2025 and M.C.C. No. 1234/25 dated 12.11.2025. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Sanjib Mandal and share the information and directed him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling to accompany as well as to assist us.

At around 22.45 hrs we arrived at Siliguri Junction and contacted with my source who stated that the person possessing huge quantity of Ganja will come to Siliguri Junction. Then, I requested two available independent persons namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 9339932433) and Raja Sahani (26 yrs) S/O Chunchun Sahani of Rajendra Nagar, Dist. Darjeeling (Mobile No 9382167087) to remain present at the spot and act as independent witness if any search and seizure would make which they agreed. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Sanjoy Sarkar and ASI Sanjoy Roy along with force came at the spot to assist us. At around 23.15 hrs on 12.11.25 my source informed me that the is standing beside the Hill Cart Road in front of old SJDA Building, Siliguri Junction and from a considerable distance he pointed the suspect. Accordingly, being pointed by the source we cordoned the place from every corner with due care and cautioned and managed to detain him with two vegetable loaded bags from his possession. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel of our team were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation he disclosed his identity as Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling. On further interrogation he disclosed that he is the businessman of vegetable and he is carrying Squash in two bags and waiting for Kolkata bound Bus.

On prolonged interrogation he admitted his guilt and finally disclosed that he kept hidden total 05 (five) packets of Ganja inside the bags covered with squash from top and he is waiting there for a Kolkata bound bus. I further informed him that the search of both bags is required; I accordingly issued notice in writing to him whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted officer which he agreed to be searched in presence of any of the above noted officer.

Accordingly, I informed the facts to you over mobile phone and requested you to arrange for an Executive Magistrate or Gazetted officer for the purpose of supervise the entire search and seizure process. At around 00.15 hrs on 13.11.25 you arrived at the spot at near old SJDA Building, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and informed me that due to mid night no any Executive Magistrate were available for supervise the process of search and seizure. You further inform me that as being a gazetted officer you are legally authorise to give order to search the bags/belongings of the suspects. I further served a notice to you to provide necessary permission to search the bags of suspect and supervise the entire process of search and seizure, if required. Then, following your direction, on camera, I offered both the independent witnesses and the detained person to search our police team but he denied for searching Police team. Thereafter, in presence of you and independent witnesses as noted above the said two bags was searched and recovered above noted five packets of Ganja which were kept hidden inside two Chayote (Squash) loaded bags. On demand the above named detained person failed to produce any valid document/papers for possessing or selling such huge quantities of Ganja (Narcotic Substance). On further grilling, he confessed his guilt and stated that he procured the said quantities of Ganja clandestinely from Cooch Behar for the purpose of selling the same in high rates to his designed customers in Siliguri/Kolkata for his wrongful gain and also stated that he is engaged in such type of illegal business for the last few months for his wrongful gain within a short period of time. Accordingly, I seized the following articles viz:- (i) One red colour packet wrapped with transparent cello tape containing 6.190 Kgs of Ganja - Marked as Exhibit-'A'. (ii) One red colour packet wrapped with transparent cello tape containing 6.264 Kgs of Ganja - Marked as Exhibit-'B'. (iii) One red colour packet wrapped with transparent cello tape containing 6.181 Kgs of Ganja - Marked as Exhibit-'C'. (iv) One red colour packet wrapped with transparent cello tape containing 6.818 Kgs of Ganja - Marked as Exhibit-'D'. (v) One red colour packet wrapped with transparent cello tape containing 6.790 Kgs of Ganja - Marked as Exhibit-'E'. (vi) one yellow colour plastic bag printed as NRSS GOLD TEA filled with Chayote (Squash) approx weight 25 kgs - Marked as Exhibit 'F', in which Exhibits 'A' 'B' 'C' & 'D' was recovered. (vii) one yellow colour plastic bag printed as NRSS GOLD TEA filled with Chayote (Squash) approx weight 35 kgs - Marked as Exhibit 'G', in which Exhibits 'E' was recovered. from the exclusive possession of accused Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling under proper seizure list from the spot in presence of you and independent witnesses and obtained his signature which are acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused person at the spot. The whole process of search, seizure and label were made under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 00.30 hrs to 01.25 hrs on 13.11.25 as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the accused person namely Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling was involved in procuring and selling Ganja illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities, informing him regarding the ground of arrest and issuing a copy of Memo of Arrest and ground of arrest. I also informed the guardian of the arrested accused person over Mobile phone duly provided by the arrested accused person.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the following accused person namely Sashi Kar (24 yrs) S/O Shankar Kar of Bagha Jatin Colony, 45/08, PS- Pradhan Nagar, Dist. Darjeeling and its investigation may kindly be arranged.
