Most Humbly, I Smt Champa Das, Wife of Sri Shibu Das, aged about 27 yrs, , Resident of Khalpara, Vivekananda Road, By lane, Ward No-7 of SMC, P.O Siliguri Bazar, P.S Siliguri, Dist- Darjeeling do here by Lodge this complaint before You to stating that yesterday on dated-10/11/2025 around 7:20 Pm my son namely Apurba Das, Aged about 9 yrs, who was came from his friend's house with his cycle near my locality in that when he was stand for crossing the M.R.Road, Near harun Tailor Shop, suddenly a Loaded vehicle (Six wheeler Goods Carrier truck) bearing number **WB-73-C-1558**, came and by the negligence of driving, the vehicle Rushed and ran over my boy body , and the back wheeler of this truck ran away from his body (lower part of stomach) and in serious situation the local people came and save him after hearing the shout I came from my house and take him to the district hospital and the doctor see his situation and in critical condition Doctor referred to North Bengal medical collge as well as suggest me to take him into better hospital because my son's condition was not good at that time and my family members take him to Anandolok Hospital situated at Sevoke Road and during treatment in **Hospital doctor declare death around 10:50 Pm.** on same day due to midnight I did not came yesterday and today I lodge this complaint.

Now I am requesting before you to kindly take necessary step from your end and take strict action against the driver of the said truck who drive the vehicle by negligency and ran the truck over my son's body and due to this my son is death by this accident. I am highly obliged with you.
