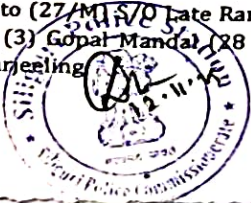

Sir,

I, ASI Rabin Lama of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Tariqul Islam @ Choton (23 yrs) S/O Kawsar Alam of South Ambedkar Colony , Ward No.01, PS- Prodhan Nagar, Dist- Darjeeling, (2) Bappi Mahato (27/M) S/O Late Ramkrishna Mahata of Kholachand Fapri, near Dunrga Mandir, PS-Bhaktinagar, Dist- Jalpaiguri and (3) Gopal Mandal (28 yrs) S/O Gyanendra Mandal of Lichun Bagan, Subhashpalluy, Ward No. 18, PS- Siliguri, Dist- Darjeeling under arrest along with following seizure articles; (i) One (01) knife with plastic handle measuring approx. 23 "Centimeter (Approx) recovered from the possession of Tariqul Islam @ Choton (knife was on his hand) (ii) One iron made Kuteri with curb in front sided including wooden handle measuring approx. 30 " Centimeter (Approx) recovered from the possession of Bappi Mahato (Kuteri was on his hand) , (iii) One (01) iron made Patti with curb in front side measuring approx. 76" Centimeter (Approx) recovered from the possession of Gopal Mandal (Patti was on his hand) ,In this regard, I beg to report that on 12.10.25 at 01:05 hrs received secret reliable source information that about 08/10 anti socials being armed with deadly weapons assembled at South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS for making preparation to commit dacoity in a house at South Bharat nagar area under Siliguri PS. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 503 Dated. 12.10.25. As per the direction of IC Siliguri PS, at 01.15 hrs, I along with ASI Debasish Das, ASI Minhaj Al Kader, ASI Samir Mandal, C/1484 Arun Sarkar, C/1563 Joy Chhetri Roy and C/160 Soumen Sarkar along with investigation Kids left for South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS for working out the information vide Siliguri GDE No. 504 dated 12.10.25 after briefing officers and force properly. At 01.25 around hrs we reached at South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS and kept our vehicle at considerable distance South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS. Then, I along with other Officers and force headed towards South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at South Bharat Nagar near Jorapani Bridge, Ward No. 24 under Siliguri PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted three persons could be apprehended and detained them. Then, after

disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 08/10 others assembled at the spot making preparation to commit dacoity tonight in a house at South Bharat Nagar area under Siliguri PS. I accordingly searched them in presence of witnesses and found ; (i) One (01) knife with plastic handle measuring approx. 23 "Centimeter (Approx) recovered from the possession of Tariqul Islam @ Choton (knife was on his hand) (ii) One iron made Kuteri with curb in front sided including wooden handle measuring approx. 30 " Centimeter (Approx) recovered from the possession of Bappi Mahato (Kuteri was on his hand) , (iii) One (01) iron made Patti with curb in front side measuring approx. 76" Centimeter (Approx) recovered from the possession of Gopal Mandal (Patti was on his hand) were making preparation for committing Dacoity tonight in a house at South Bharat Nagar area under Siliguri PS but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 01.45 hrs and 02.25 hrs dated 12.11.25. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at South Bharat Nagar area, but others managed to escape from the spot.


From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at South Bharat Nagar area.

Further, it to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.


Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 08/10 others who fled away, under proper section of law and to cause its investigation.
