Respected Sir,

I, Chhattu Roy, Son of Sri Ulkanta Roy, residing at Chayan Para, Post Office Rabindra Sarani, Police Station Bhaktinagar, Dist Jalpaiguri, Pin 734006 would like to state you that on 09.11.2025 at about 10:30 am. after purchasing some grocery items from a shop situated at Kalisha More, while returning home my neighbour namely Kamal Sadhu, Resident of Chayan Para, Post Office Rabindra Sarani, Police Station Bhaktinagar, Dist Jalpaiguri, Pin: 734006 suddenly became violent and started abusing my younger brother namely Rahul Roy, Son of Sri Ulkanta Roy in filthy language and threw a big stone which struck his right leg, causing his severe pain and injury. At that time my brother asked why he (accused person Kamal Sadhu, residing at Kalisaha More, Chayan Para, P.O. Rabindra Nagar, Dist. Jalpaiguri) had thrown the stone to him. After listening this word, he continued to threaten my brother and my family members with dire consequences.

Sir, I further state that the above named miscreants then slapped my brother, used abusive Language and also hit him on his nose - resulting in a fracture. Subsequently, he was admitted to Siliguri District Hospital on 09.11.2025, where he received medical treatment and was discharged on the next day i.e. 10.11.2025 (A copy of the Medical Discharge paper is annexed herewith).

Sir, due to ill health, my brother was advised to take bed rest by the doctor and therefore could not approach the police station earlier. As an elder brother I am lodging this written complaint before your good office against the above named miscreants namely Kamal Sadhu for committing the offence of **physical assault by breaking my brother's nose**, criminal intimidation and use of abusive language against my brother and my family members.

Under the above circumstances I request you to kindly take the necessary action and investigate the aforesaid matter against the above named miscreants namely Kamal Sadhu and punish him as per law.
