I am Moumita Chakraborty, resident of Gunning  
Busti, Padmanagan, Champasani, aged about 26, Daughter  
of late Tapan Chakraborty, having aadhar card no.  
Bearing 256792480747 and personal mobile no. Bearing  
71047861395. Was working for gain in GNC having  
registered address at Serok Road, opposite Hotel  
Maya, 734001 from 09.06.2025. This is to further  
inform you that on 12.06.2025 I entered into a  
marital relationship with Pritam Adak (Adhar no. 812565  
109196) having marriage registration certificate no WB  
3270040010100002744-2023-74055, registered on  
and from 12-06-2023 by Shrabani Chakraborty, Aulhal  
place, 107/1/A/N/Patel Road, Near T.B Thapa Nepali  
School, Ps-Padmanagan, Pin-734003, Dist-Doojelling,  
West Bengal. In the aforementioned address I was  
cohabiting with my husband for the last two years.



This is to bring into your notice that from the early days of our marriage my husband demanded money from me and treated me with anger and rage often he used to physically abuse me for the want of money. My father passed away on 30.07.2016 and my mother is terminally ill and had fallen victim to depression and become mentally disabled for that last few years. I do not have any support from my family and I am earning for my living. My husband never supported my professional ambitions and mentally harassed me for reasons best known to him. Despite my issues of family and mother, my husband never acknowledge me or supported me in anyway. He mocked me in even corners and accused me of having affairs with other men privately and also publically.

A few months ago when he threatened me for money again and humiliated me for not having sufficient means, I left the house and

come back to my mother's maternal house with all my belongings, baffled with fears of my own life and security.

The issue became unbearable on 23rd October at about 4pm when my husband followed me to my office in rage and with maliced intention to harm me inside the office premises.

This to inform you that he pushed me in the stairs of the office when I was about to leave in tears. Despite my best efforts, he followed me and struck me in my head thereafter I fell unconscious. I regained consciousness a few minutes after and I saw him dragging me in the street of Hongkong market Siligoesi. Publically no one came to my rescue. My mobile was taken from me by my husband. I was unable to call the Police authorities.

After regaining consciousness my husband started abusing me, and again physically assaulted me thereafter I called the police by taking my cellphone from my husband. After arrival of police



I was immediately taken into city hospital.  
Siliguri.

I am living in fears of my life every day and I am unable to go to my office in fear of my life. Finding no other alternative I am praying to authorities to accept this letter as a formal complaint against Pritham Adak and such atrocities caused to me. I would request the department to take appropriate steps against my husband and do the needful.
