Darjeeling, Pin: 734003, in the State of West Bengal would like to request you for your kind information and necessary action as follows:

That I got married with Sri Abhijit Mondal of Bhanu Bhakta Sarani Ward no. 3, P.O & P.S Pradhan Nagar, Siliguri, District - Darjeeling . The marriage was initially registered on 19/04/2019 and thereafter we socially married on 14/08/2019. I have given birth a daughter in the year 2020 during the said wedlock. After marriage I have been living with my husband in my mother-in- law and one elder brother-in-law who is mentally ill. It is also a fact that after my married my husband decided to live separately in the same premises though he had taken care of everyone. My husband now a days have developed some freaking habits such as he sometimes stared unwanted quarrel, used slang language and always tried to throw me out of the house stating that I am a Bhutia Nepali tribal person and his mother does not like me, they wanted me out to get of house forever.

When the topic of marriage came up I started visiting his house, but his mother didn't like me at all. When I discussed this matter with Abhijit he said my mother mental state isn't stable right now because my father passed away, and my eldest brother also passed away. My eldest brother mental health isn't good either. Everything will be fine after the marriage

Before the wedding, Abhijit needed some money to buy a project, so my brother-inlaw look a loan of Rs.10,00,000/- (upees Ten lakhs) from SBI bank Salugara and gave it to Abhijit, Abhijit said that there was an ongoing case regarding a piece of land, and once it was resolved-within a year he would repay the loan . Until then, he would continue paying the monthly installments of Rs.18,000/- (Rupees Eighteen Thousand). But after a few months he couldn't even pay the interest then around 6-7 year later when my brother-in-law asked for the money back that's when the problems started some money is still remaining to be paid but it hasn't

been given yet. Even my family is not asking for it so that there is no issue in our relationship.

That on 10/11/2025 in the evening at about 7 p.m. I called my husband and told him I wasn't feeling well and asked him to get out daughter ready and drop her at school. After waiting some time our daughter still wasn't ready, so I got her ready myself and told him to take to school. Later, 3:00 o'clock he brought our daughter to me and said, "Look after her- am going out and went downstairs . I called him and told him he hadn't fed or bathed our daughter (and that my health wasn't fine, as he knows). He started shouting at me. I answered back and an argument began between us. His mother came between us and started yelling at me, saying I am rude to her son, telling me to go outside with a bowl and beg, insulting my appearance (saying my face looks like a flatbread). And ordered me to get out of her house. After that, in the evening, he came to my room and started kicking me, tear my wear cloth, using slang language with me and my Nepali tribal Caste and pulling my hair, hitting my head against the wall and I felt down and they leave me at that condition with in locked room. That very next date dated 11-11-2025 I with the help of my wisher go to Siliguri District Hospital for my treatment and thereafter Doctor has prescribed some test and medicine for my cure.

Respected Madam, My husband has pawned all my jewelry and used up all the money. He took out loans from six banks in my name, now that I have nothing left, he filed for divorce without even telling me and now the day my husband threaten to me for dire consequences if I will not fulfill his demand amount of Rs.5,00,000/- (Rupees Five Lacs) from my parent.

So, Respected Madam, under the above circumstances I humbly request you kindly enquire the matter and take necessary action against my husband namely Abhijit Mondal and my Mother-in-law as per provision of law. For this I shall always oblige to you. Madam due to serious condition of my health I was not lodged written complaint in due time so today I am lodging my complaint before your Police Station.
