Sir,

I, **PHEKU SAHANI**, son of Late Bijnandan Sahani, permanent resident of Vill. Khudirampally, Bhangapul, P.O. & P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That **PRADIP KUMAR SAHANI** (aged about 33 years) is my son who works at Adani Oil Depot at Rangapani Canal, behind Petrol Pump situated at Vill. Rangapani along with his friend namely **GANPAT SAHANI**, son of Sri. Lal Sahani, resident of Bhujjya Pani, Biman Nagar, P.O. & P.S. Bagdogra, Dist. Darjeeling.
2. That on 07.11.2025 at about 8.52 P.M. my above named son and his above named friend were returning from their above mentioned place of work and were heading towards my house on a motorcycle bearing registration No. WB 74 BN-5571 which was been driven by said Ganpat Sahani having my son as a pillion but suddenly one **Four Wheeler Mahindra Scorpio (Colour-White)** bearing Registration No. WB 74 Y-8766 which was been driven recklessly at very high speed dashed both the motorcycles from behind at Embee Fortune, Near Sanyashi Mandir, Vill. Baramohansing Jote, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling. As a result the both of them fell on the road along with the motorcycle and my son and his friend received severe injuries. Due to heavy blood loss my son became unconscious. The above mentioned Four Wheeler escaped from the spot immediately. The local people arrived at the spot and said Ganpat Sahani with the help of the local people took and admitted my son at **SUN HOSPITAL** at Chiriya More, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling. At about 9.30 P.M. said Ganpat Sahani informed me about the whole incident through his mobile phone and I reached at the said Hospital within few minutes. I came to know that due to the accident my son's left leg, his right leg's ankle was broken and also received several injuries in his head and shoulder.
3. That on 12.11.2025 my said son undergone a left leg surgery and is still in a critical condition.
4. I therefore, request you to kindly take necessary legal steps against the driver of the said **Four Wheeler Mahindra Scorpio (Colour-White)** bearing Registration No. WB 74 Y-8766. I shall be highly obliged to you forever.
