Respected Sir,

I am writing to lodge a formal complaint regarding a road accident that took place near *Air View More*, Siliguri, involving our school van and a bus bearing registration number **WB 73 G 3638**.

On 13th of November, our school van was transporting students when the above-mentioned bus, driving at a high speed and in a rash and negligent manner, collided with the van. As a result of the impact, several students and the driver sustained injuries. Immediately after the accident, the bus driver fled the scene without stopping to assist the injured or take responsibility for his actions.

This reckless behavior endangered the lives of children and caused serious distress and injuries. We request that a thorough investigation be initiated at the earliest to identify and apprehend the
