Respected Sir,

With due respect I, PUSHPA DEVI SHARMA, Wife of Sri Jagadish Prasad Sharma, Resident of Agrasen Road, Back side of Agrasen Bhawan, Khalpara, P.O. Siliguri Bazar, P.S. Siliguri, District-Darjeeling, would like to inform you that I and my husband namely Jagdish Prasad Sharma are senior citizen. Sir, on 13/11/2025, between 01:30 PM and 02:00 PM, some officials from the Siliguri Municipal Corporation Building Cell visited my house to inspect our property. They inquired about our building construction and asked about Vijay Kumar Sharma's whereabouts. After they left, Purshottam Sharma (Dholu), Madan Mohan Sharma (Mukesh), and their father Vijay Kumar Sharma arrived at the spot. Purshottam Sharma (Dholu) and Madan Mohan Sharma (Mukesh) were intoxicated and came with the intention of harming our family members. They started pelting stones at my house and quarrelled with my husband. Suddenly, Purshottam Sharma (Dholu) and Madan Mohan Sharma (Mukesh) picked up batons lying beside our gate and assaulted my husband. I, being a lady, tried to protect him, but Vijay Kumar Sharma pushed me, causing me to fall down. After hearing our hue and cry my sons namely Vikash Kumar Sharma and Nitin Kumar Sharma came to our

rescue and surprisingly said Madan Mohan Sharma hit my sons with the battam in his hand and Purshottam Sharma (Dholu) assaulted my son namely Vikash Kumar Sharma with fist and blows. In between all this incident the local people gathered and they ran away after attacking us. At the time of leaving, they threatened us, saying we should be prepared for dire consequences and be ready to mourn the loss of a family member. Thereafter we went to the nearby medical shop for treatment. The abovenamed accused persons did this type of offences several times and several cases were also pending against them and at present we are in fear due to their acts and activities.

∴ Therefore, I request you to investigate into the matter and appeal you take legal action against Purshottam Sharma (Dholu), Madan Mohan Sharma (Mukesh) and their father Vijay Kumar Sharma, so that they would be punished as per law and thereby I shall be obliged to you.
